### OPINIONS & PROPOSALS

Hartley Patterson, 7 Cambridge Rd., Beaconsfield, Bucks, ENGLAND; March 2, 1972

On Conventions - Lew's proposals seem a perfect opprotunity for feuds and factionalism. SF fandom has faced similar problems in the past. The system at present in operation for the WorldCon is as follows:

There are three zones (East/Central/South) which rotate the WorldCon between them. In any year a foreign bidder may try for the Con, but the Con may not leave North America two years in succession. Bids are voted on at the business meeting of the World SF Society, which exists for air charter purposes and meets at the WorldCon. Bids are made TWO years in advance, and must be confirmed the following year.

Diplomacy fandom is probably too small as yet for this. In the UK the annual SF convention is held at Easter, and bids are made ONE year ahead. The chairman of the meeting at which bidding takes place is by custom the chairman of the British SF Association AGM, which proceeds the bidding meeting. It has always been understood that the BSFA will organize a Convention if no bidders should appear.

I suggest (1) that the DD should set out a series of guidelines on how a Convention should be run (2) That it offer to sponsor the Convention. This latter would involve on the one hand DD members publicising the Convention in their 'zines, and on the other the Con Committee including at least one DD member who would act as liason officer and ensure that the Con is run properly. This is the system that has been used in the UK; it seems to work.

For the DD to <u>run</u> the Cons (as Lew seems to be suggesting would be wrong. In the UK for various reasons a number of people are opposed to the BSFA. In the USA as I understand it a number of people are opposed to the DD. Would John Boardman support a Con controlled by the DD?

Either a broadbased Org should have the DipCon duty or else an <u>ad hoc</u> group should be formed each year. I propose that we have a written set of by-laws.

Stephen Marsland, 78 Genesee St., Greene, N.Y. 13778; March 1972

I propose the following:

- 1.) A standard code for dealing with a player's country once he has dropped out with an acceptable alternative to substitute players in case they cannot be found.
- 2.) A way of guaranteeing substitute players to all GM's everywhere rather than the alternative mentioned in (1) above.
- 3.) One standard publication which will give clear, unbiased information on what's going on rather than personal views on someone else's stupidity, pig-headed opinions, ignorance, etc. ad nauseum.
- 4.) That we move immediately on Lew's proposalz and get down to writing the final draft.
- 5.) That we update PONTEVEDRIA, bring in more information (I didn't get very much out of mine) and make it a "Congress" activity rather than Rod Walker's.
- 6.) That a standard set of House-rules be set up and included in PONTEVEDRIA, then GM's could make minor adjustments for their own 'zines rather than do it all themselves.
- 7.) That the Congress set up or adopt a rating 'zine which the members would use and adhere to.
- 8.) That comments and proposals no longer be limited.

Len Lakofka, (address on page 1); March 1972

Both the "NewOrg" and PDC have now shown interest in DipCon sites. Once the "NewOrg" is established, its wider base of membership could vote on the recommendations of the PDC vote (or committee). All bids should, of course, be Public and Printed Prior to a vote on the final site.

DIPLOCON V does plan seminars and business meetings as part of its internal business. We hope to hold business meetings on Saterday evening from 8pm-midnight.

If this group isn't going to die on the vine, we've got to start doing something. Discussion is fine, but action is better. For starters I propose that we initiate some sort of procedure to standardize everyone's House-rules as much as possible. In fact, once a standard set is adopted, I propose that their use be made a requirement for membership. The result would be a big service to all players.

Rod Walker, (address on page 1); February 26, 1972

My proposal to establish Lew Pulsipher's proposal is important and vital. an independent commission has fallen on stoney ground. It is therefore necessary for the PDC to take action. Once the new Diplomacy Organization is operational, we should discuss with them a cooperative arrangement, whereby that group (representing players) and ours (representing Gamesmasters and others) will each have a xxxx voice in site selection. Enclosed is a map with the suggested boundaries per Lew's suggestion (and including Canada). The boundaries are about what anyone might draw, except that Virginia is in the East in order to clarify the position of Washington. D.C. I propose we vote on creating this Commission each year, authorizing Lew to draw up a final plan which we can then accept or reject by vote. As a separate proposal, I suggest we do not require the Convention to be in a different area each year, but establish this as a guideline to be followed where possible, and a standard rotation of areas for each 5-year period (e.g., West-Midwest-East-South-Canada). I request a vote on wheither this is to be a requirement or a guideline. I do not believe that our plan for a commission need rest on the approval or disapproval of the people at DipCon V. In fact, the commission should be active long before then, working on a site for DipCon VI (in the East if my rota proposal is adopted), so that when DipCon V convenes, the site of DipCon VI is already known. As Lew points out, most of the people who organize Diplomacy activities are members of the PDC. It is not a question of who has the "right" to do this, but who is in a position to do it. If what we do is fiar and equitable, we will perhaps get complaints from those concerned with power politics and personal aggrandizement, but none from those with the good of Diplomacy at heart.

Buddy Tretick, (address on page 1); March 2, 1972

Comment to the Chief; Please advise if there will be any attempt to require members of the PDC to conform to a specific set of rules or procedures.

I agree that a committee should be established, consisting of volunteers, to choose the site and plan other activities of DipCon.V. However, since Len has possibly laid some ground work in this area, he should be invited to work, but not head, such a committee, and that fife the committee should coordinate with Len's initial efforts.

Or should the chairman be chosen from outside I would like to suggest that the chairman be selected from outthe commission? side the commission (so as to have a tie-breaking vote, but no other voting powers, ala the role of the Vice-President as President of the US Senate). to be used follows: each of the four geographic regions has a slate of candidates (all volunteers, of course!) from whom two reps shall be elected to serve on the Before this election takes place, one of the candidates from the region where the year's convention is to be held is selected by lot or vote to act as the year's chairman of the commission. The commission would be composed of three members from the convention region (one the chairman) and two from each Of course, there is the problem of insuring that all the of the other regains. volunteers are competent to serve; if the eligibility is restricted to members of this organization, this would, hopefully, reduce or eliminate the problem. would be no limit on the number of times a person could volunteer, and if need be, this whole system could be modified to allow terms of office for the members of the commission to be longer than one year. The chairman would still be limited to a one year term of office.

#### OTHER BUSINESS

New Appointments:

Lew Pulsipher has been appointed Variant Orphan Games Director succeeding P.M. Gaylord to that position. Bob Johnson and Stephen Marsland are appointed to the By-laws Drafting Committee which will be responsible for producing a set of written rules for the operation of the PDC. The Chief of PDC will be the Chairman of that committee.

A request from the Chief:

I would appreciate a short description from each publisher in the PDC of the manner in which his publishing activities and records are organized. These descriptions will form the basis of a series of articles on the current state-of-the-art of Diplomacy publishing. In this way new publishers will be able to avoid some of the difficulties involved in getting started as a publisher.

Director's Reports:

All PDC Directors are requested to submit reports of their project's activaties for publication in the next issue of ACHERON. The U.S. Data Center project has transfered publication of TERMINUS to Walter Buchanan. Currently, the USDC is attempting to compile a listing of all postal Diplomacy players and their opponents. A number of difficulties have been discovered with which have delayed the completion of the listing. A primary difficulty is the size of the list involved and the lack of an efficient listing format. Until these difficulties and others are resolved, the opponents listing will not be published.
