BALLOT RESULTS: Of 35 ballots outstanding, 24 were returned. Submitting ballots: Barber, Beyerlein, Borecki, Buchanan, Caylord, Johnson, Just, Key, Krigsman, Lakofka, Lobling, Lindsay, Mensinger, Miller, Naus, Reinsel, St.Cyr, Schleicher, Smythe, Trotick, VanAndel, Walker, Ward, Welsh. Failing to return ballots: Childers, Holeombe, Manogg, McCallum, McDuffic, Schaefer, Wells, vonMetzke. Other non-returnces: Calhamer (honoraxy; not required, but would be appreciated); Turnbull (British postal strike); Warden (joined after deadline).

Item 1: Removal of inactive members: Yes, 20; Ho, 4.

Inactive = failure to neturn: 2 conscutive ballots, 8; 3 consecutive ballots, 15; no vote, 1.

Item 2: Admission of Borck Helson: Yes, 20; No, 0; Abstain; 4.

Item 3: Ballot deadlines should bo: 2-3 weeks, 5; 3-4 weeks, 12; 4-6 weeks, 3;

6-Sweeks, 1; Other, 3 (1, 3-6 weeks; 1, 1 month; 1, abstain).

Item A: Homos for "orphan" games were offered by: Gaylord, Johnson, Just, Lakofka, Mencinger, St.Cyr, Schleicher, Tretick, and VanAndel. Thank you, gentlemen. I will be making use of this information in future.

Actions to be taken: 1. Members who fail to return 3 consecutive ballots will be declared "inactive" and dropped from the rell of membership. I think it only fair, however, to reinstate these members if they are otherwise still eligible for member-chip, request reinstatement, and return the next ballot. Late Rallots: I will count any ballot which is received after the deadline but before I have actually typed the ballot results in ACHERON.

2. I will upite Mr. Molgon and invite him to join.

3. The members obviously profer, on the whole, shorter deadlines than I have recommended. So be it. Deadline for receipt will be generally 3-4 weeks from distribution. The next ballot will have a slightly longer deadline, so as to coincide with the deadline for Division Chief nominations. The one kicker in this is that I cannot afford, in terms of either time or money, to produce 12 issues of ACHERON per year. See below for some thoughts on this problem.

MONEYAMONE: Please remember that nominations for the position of Division Chief, 1971-1973, must be received by me on or before 1 April 1971. If the candidate is not now a member of the Division, he must join by them. You can nominate yourself. Any condidate may submit to me a campaign statement, printed on one or both sides of a single sheet of paper, in 50 copies, to be distributed with ACHERON 6. Only one person has thus far been nominated (Rod Walker), and my campaign statement is enclosed with this issue. I will not distribute a second statement with ACHERON 6, since each candidate ought to be limited to only one such distribution, in the interest of fairness. What candidates send out on their own is another matter, of course.

THE DIRECTOR SYSTEM: Since the Division Chief's time is severely limited, the only way we are going to get new projects on the road is to have other members become responsible for them. Members who have projects they would like to undertake for the Division should contact me. If the project is a necessary one, does not overlap current projects, and does not involve any financial obligation on the part of the Division, the Division Chief will appoint the proposer Director of that project with certain specified responsibilities. A standard responsibility will be the aubmission of progress reports on ballot deadlines for publication in ACHERON. Division Chief will replace inactive Directors and/or cancel inactive projects. the project does involve a financial obligation on the part of the Division, the members will have to vote on the question in order to determine whether they wish to lay out the cash. Hembers who have ideas for projects, but don't want to direct them, should write me anyway, and we'll see if we can't find you a Director. A Director must of course be a member of the Division, but if somebody is directing a Division project, that seems to me sufficient qualification for membership. Ideas, comments, suggestions, support for, or opposition to any or all of the foregoing will be welcome, of course.

THE ARCHIVES PROJECT. Some of us have long been concerned with the preservation of the "heritage" of postal Diplomacy; that is, its published record in the form of gamesines, geneines, propagandasines, and what-have-you. It was and is our hope to:
(1) to locate and catalogue all major repositories of postal Diplomacy material (all of which are private collections), (2) to insure as much as possible against the loss or destruction of these repositories, and (3) to make available to any interested party originals or copies of any items he may desire, and to do so at a reasonable price. Otherwise, the time will come-if we do not act now-when many rare items will have vanished forever or will be available (if at all) only at an outrageous surcharge. I have therefore taken action to give impetus to this dermant but necessary project.

ARCHIVES DIFFETOR. I hereby appoint Walter Buchanan, editor of HOOSIER ARCHIVES, as Archives Director for the MFFFGBDB, to serve until resignation or replacement.

Mr. Buchanan is intensely interested in the bibliographic end of our hobby and has already begun to amass a considerable collection of material. If current possibilities joll, Mr. Buchanan at year's end will possess one of the most complete collections of original materials in the country. His little gensine, HOOSIER ARCHIVES, began as a listing of his holdings and a request to purchase materials. It is now turning into a first-rate bibliographic review and will in addition reprint out-of-print and hard-to-get items. Mr. Buchanan offers merox copies of any items in his collection at very reasonable rates. Subscriptions to H.A. are one stamped, self-addressed envelope per copy. Issues 1-4 available.

In the coming months I hope to help Mr. Buchanan obtain a complete catalogue of the major Diplomacy libraries in the country-particularly those belonging to Moore. Ecardman, Key, Alderson, Koning, Walker, Wells, Miller, McCallum, Phillips, and possibly other major collectors. We will then want to insure that an original or a copy of everything is on deposit with Mr. Buchanan. Malt has already, because of his abiding personal interest, gone to considerable expense in this, and will continue to do so if necessary. No expenditure of Division funds is involved. Those of you who can help him in this project are urged to write (address, page 1). Particularly—if you have Diplomacy stuff sitting around you no longer need or want, bundle it off to Walt 3rd class—and please urge your readers to do the same. Since Walt's storage facilities are limited at the moment, you could also send bulk material to me. Proper storage of excess material new will insure future collectors at least some criginal copies out of this dim era.

DIVISION AFFILIATION. I would like to request that all editors/publishers who are members of the Division make some notation in your 'zine to this effect. Just a single sentence (see EREHWON or ADAC for a sample) would be nice. Please?

PONTEVEDRIA. This is a new Division 'zinc, in addition to ACHERON and GEHENNA. Like the latter, it goes to people it concerns, not to members. It is log a copy. The purpose of PONTEVEDRIA is to introduce postal Diplomacy to "new blood". Issue #1 (21 February 1971, App) mentions the crigin of the hobby, discusses 11 Diplomacy "conventions" ('Zine names, trade agreements, the 5 seasons, rules disputes, press releases, Boardman Numbers, the Gamesmaster, stand-by players, General Orders, the game fee, and deadlines), lists all game openings known to me, lists active genzines, and discusses variant Diplomacy. A copy is being sent to all "new blood" of whom I become aware. This is another service of our Division and your dues will (I hope) help subsidize it.

Flyers. I am willing to distribute flyers with PONTEVEDRIA. Each flyer must be printed on one or both sides of Sgxll (or smaller) paper. It may consist of anything: advertisement, a one-sheet sample of your taine, whatever. This service

is available to Division members only. It will cost you: le a flyer. Please send me a batch of 50 (and 50%) or a batch of 100 (and \$1) (no more), and I will see they are distributed with FONTHVEDETA. Places be sure that whatever you say about game feer, sub feer, 'sine content, &c., will hold true for the next six months at least.

"ORFHAH!" CAMES: The Division Chief is actively engaged in restarting such

games. Recent and oursent projects:

1. The Evens "Fournemente". GEHENNA #5, 29 January 1971, went out on this, cont to active and "Cropped" players alike (since some players, at least, were "dropped" without sufficient cauce), with a 1 March Condline for reply. Evans is till in Bakersfield, but refuses to respond to letters on the tournaments. It is proposed in CEMERIA 5 that the 39 "counnament" games to cancelled and expunged from the records, and a new, smaller, courtement be organized for those players who are interested. Response thus far has been very spotty.

2. BULBRUGHAC. CEMENIA #6, 8 February 1971, went out on the apparent demise of Mulle's taine. It turns out that he has simply refused to answer my letters on the subject. Our trade agreement is now (?) reactuated, so that this may not happen

osain-however, BROB #109 is already more than a month late....

3. THE THE INCIDENT. The proposed transfer to Harry Maneg will be effectived by the Division in not undertaken by the 28th by the present editors. More on this in AUTERON 6.

A. PROMEROGARD. Louis Monghert's FRIGATE has marged with LEGATUS. However, Axel Uniqueen is experiencing some publiching difficulty and, in addition, Axel hopes to go to WestPoint next year. Wegotiations are now under way to transfer the LECATUS and PRIGATE gamen, at least temporarily (until Axel can publish again) to another Unmomnaster. More on this in ACHERON 6.

5. MEAR /RACHARON. John Koning's games have been hanging fire for some time, now. John has remained active in games, and has indicated frequently that he would publish "goon". I am going to unite John on this. Perhaps a temporary GM/publisher

until John is ready to publish again himself on a regular basis would be the answer.
6. LA CUPREE. Some of Euddy Trotick's games are stalled for lack of replacement players. Any help in finding stand-bys for Buddy would be appreciated. I will be in seach with Eudly on a game-by-game basis in order to assist him in getting them moving again.

VARIANT "OPPHANS". The Division operates through CEHENNA to find homes for regular games. I have imposed this limitation because that's all I have time for and because I don't keep records on variants. Would anybody like to perform this same service for variants? There are some which need it, I think.

ACHERON'S SCHEDULF. A monthly schedule for ACHERON, which is presupposed by monthly ballot deadlines, presents difficulties, as already noted. First, finance: once postal rates go up (May), I will not be able to produce and mail a copy of the ising for less than 10g--which means a yearly expenditure per member of \$1.20, 20% above current dues (and, in addition, nothing left over to finance other Division projects, such as GIMIETWA and PONTEVEDRIA). Now, I'm willing to sink some of my own money -- as well as my time -- into this, but I'd like to hold it to a reasonable level. We could raise dues, but I'd rather not if it can be avoided.

Second, I am presently blessed with considerable spare time. Sconer or later this is going to be out oractically-certainly by May if not before. The time to type, publish, collete, address, and mail copies of ACHERON once a month may not

be available.

As a temporary expedient, two things are likely. First, while I will publish ACHEPON at the first available opportunity after the ballot deadline, there is likely to be some delay, possibly emounting to two weeks or more (this issue is dated 12 days after the last deadline, e.g.). Second, some issues will not have ballots. I don't like that idea, because even if there is no pressing matter up for vote, I often have things I want to solicit your opinions on in an "edvisory" vote.

I am most interested in ideas you may have on this. The enclosed ballot has

a section devoted to some specific questions in this area.

A DIVISION GENZINE? There has been, and still is, a lot of interest in having within the Division a general opinion/information taine in which members could have letters published, address changes could be posted, and so or. The Monche wrench in the works has been that we have nobody to edit and publish the beast. We still don't. However, I would like to suggest how such a spine would operate and ask for additional ideas--perticularly ideas as to whom we might stick with putting it out.

This 'sinc--lot's callit THE PRATFLER for want of a name--would be primarily for Division members and would probably publish only material for them and from them. It could use differential subscription rates-c.g., 10/\$1 for Division members, 10/ \$1.25 for Bureau members, 10/\$1.50 for all others. It could, of course, trade (oither with Division members only, or with everybody). THE PRATTLER would appear approximately 2 weeks after the previous issue of ACHERON. That way, people could got in letters on the various ballot items and members could read them before the ballot deadline. This would provide the kind of debate-contact that some members have wanted and which I have been unable to provide. THE PRATTLER could, in addition, carry sympocia on various questions, such as those in DIPLOMANIA, and any other items its editor folt would be of general interest.

What do you think? Would this be worth it? Even more important -- do you know of

comeons who would like to undertake such a project? See the enclosed ballot.

SPECIAL REQUEST: I would like to ask, please, that comments and other material you send in response to this issue be put in a separate letter -not on the back of your ballot, not with game moves, and not with other matters you may be writing me about. This will help me keep track of things better; my subject file gets confused when it has to cope with several items on a single sheet of paper.

Well, that does seem to be all. Time is growing short, and I'd like to get this out tonight.

CAMPAIGN STATEMENT -- Rod Walker

First, I would like to emphasize that, although this is printed on the back of the last page of ACHERON, this in no way represents official Diplomacy Division material. I'm doing this to save paper, actually. I'm also testing out my new typewriter. You like?

I am running, as you know, for election to an office which I have previously held by appointment. I base my campaign for election squarely on my record and upon my policies. If I am returned to office, it is my intent to continue the policies and programs already instituted.

It has been said that if you don't blow your own trumpet, nobody else will blow it for you. So here we go. I have served as Division Chief for two years. When I was appointed to this position, the Division had 9 members (of which 3 have subsequently ceased to publish) and had been almost completely dormant for a very long time. It was quite literally an organization in name only. The first several menths were a period of groping, of trying to find workable programs and procedures; in fact, I did not settle much of importance in my own mind until about 6 months ago.

Today, the Division occupies an enviable position, in some ways. It is the only active Diplomacy organization of any kind in the country. It has a membership of three dozen Gamesmasters, Editors, Publishers, and other important personalities. This represents a coubling of our membership over each of the last two years.

Coupled with this growth of membership, we have begun a vigorous expansion of our activities and programs. It is my hope that over the next two years we may continue to increase our services to postal Diplomacy. A firm and good foundation has been laid; we have only to build upon it.

What do I offer, as a candidate for Division Chief, in this regard? Most importantly, I offer you a firm and experienced hand at the wheel. Second, I offer realistic leadership. I do not propose to offer you the meon, and promise to the solution of all of postal Diplomacy's problems by the institution of fantastic new programs and procedures yet unheard of. I offer the Division as much work as one very busy human being is capable of doing, plus the prospect of an organized team of workers doing even more under consistent and centralized guidance. This system will yeild results—maybe not fantastic results, but something good and solid and respectable.

Let me say it plainly--for me this election is a vote of confidence. It is a vote of confidence in my ability to administer the Division for two more years; a vote of approval of what I have done and propose to do; a vote favoring the structure and machinery of the Division as they are currently set up. I assure you that you will have a chance to vote on these questions. If, in the remote chance I am the only candidate, the April ballot will ask for a "yes" or "no" vote on my reelection.

I promise you that if I am elected, the Division will continue to progress, and it will progress in directions already laid out for it.
