Queen E. Barbara Philip addressed the REUTERS--May 1904--NAPLES: Italian Government-in-exile: "Even while the barbaric hourdes of Magyars overrun the eternal city, I ask you to go throughout the world in quest of peace. Let that nation who cannot see, cannot hear, cannot speak, and cannot understand side with these aboriginies. Implore, my ministers, all civilized nations who respect and honor mankind to side and unite with Italy against these destroyers. We, in Italy, have felt these reincarnations of the four horsemen and beg the other nations to make a concerted effort to end these marching hordes before civilization is destroyed and Mankind is returned to the torch and club. Its Barbarism will be measured in Millenia. God speed and may he bless you with success for his names sake as Man was created in His image."

Underlined moves fail. The English F Norway is dislodged and may retreat to either the Barents Sea, the Norwegian Sea, or to the Skagerrak. Other players may make their Fall moves conditional on the direction of this retreat, which is to be submitted, by the English player, along with his Fall moves. MIKE CELESTRE, the German player, writes:

Dear sir, the government of N. von Rijn wishes to make it known that it believes there has been a foul committed against the German moves ((for Fall 1901)) and wishes that you would reconsider your decision on our last moves. Furthermore, we are certain that the gamemaster was merely in error, and that as a reasonable judge ((?)) will find in our favor. Although I do not have a copy of the Diplomacy rules, I consider the point plain enough that it is uncontestable. An army or fleet can do one and only one thing at a time: either move, support, or convoy (in the case of a fleet). Now if a position is attacked, say Paris, then that army must then defend, and cannot support Picardy as it was ordered to do. The same, I understand, is true for a fleet. If, say, a fleet was ordered to convoy an army from Yorkshire to Holland, and that fleet was attacked, the convoy would fail and the fleet would be forced to defend against the fleet in Denmark, as was the case.

Since the North Sea convoy of Yorkshire to Hollland could not take place, then the German move of Kiel to Holland must have been without opposition.

I trust that the gamemaster and my most honorable fellow sovereigns will see the logic in my argument and change the ruling on Germany's moves which were, again F Denmark-North Sea, A Kiel-Holland, and A Munich-Ruhr. The move F-Denmark-North Sea cancelled the English convoy, and therefore, the English army did not move Yorkshire to Holland. So, finally, the German move Kiel-Holland did take phace.

Reply: Unfortunately, though it seems logical that an attacked fleet should be permitted to carry out its convoy order, the rules permit it! The rules state that a convoy is not disrupted by an attack which does not dislogge one of the the convoying fleets. To our knowledge, all other gamesmasters rule this way. However, since you feel a great injustice has been done, we will do this: if three other players (or more) in this game (which will make a majority) agree with you that this ruling is contrary to the rules, we will set it aside, and the game will return to Winter 1901, with Germany being allowed to build an additional unit. If you cannot get three others to agree with you, Mike, then the ruling will have to stand. OK? All players are repuested to include their vote on this matter with their next moves.
