# CONVOY'S AREN'T A PUZZLEMENT

# by ERIC VERHEIDEN

# Part 1

To resolve Pandin's Paradox and eliminate ambiguities in the convoy order, it is necessary to expand Section XII, Paragraph 5 of the 1971 Diplomacy Rulebook. Essentially, that paragraph states: "A convoyed army's attack may not protect any of its convoying fleets."

1. ENGLAND: A Lon-Bel, F Eng C A Lon-Bel, F Nth S A Lon-Bel

FRANCE: F Bel-Eng, F Bre S F Bel-Eng

Since France is attacking the English Channel with support and the English Channel is not supported, F Eng is disloged and A Lon is not allowed to move.

2. ENGLAND: A Lon-Bel, F Eng C A Lon-Bel, F Nth S A Lon-Bel

FRANCE: F Bre-Eng, F Bel S F Bre-Eng

For the same reason, the adjudication is identical. Without the rule of Section XII, Paragraph 5, it is not sufficiently clear that A Lon failed to reach Belgium, thus cutting the support of F Bel and preventing F Bre-Eng from succeeding.

To understand the adjudication of convoy orders, it is essential to grasp the significance of whether or not a convoyed army is allowed to move; and when the army is allowed to move, whether or not it is permitted to cut support.

3. ENGLAND: A Lon-Bel, F Eng C A Lon-Bel, F Nth S F Eng

FRANCE: F Bre-Eng, F Bel S F Bre-Eng

England's convoying fleet is validly supported, protecting it from France's supported attack with or without the convoy. What is relevant in this example is that A Lon does move, but since it is made explicit by Section XII, Paragraph 5, that F Bel is "supporting a fleet which is attacking...the convoying fleet" of the attacking convoyed army, "that support is not cut."

4. ENGLAND: A Lon-Bel, F Eng C A Lon-Bel, F Nth S A Lon-Bel, F Wal S F Eng

FRANCE: F Bel-Eng, F Bre S F Bel-Eng

\*\*\*\*\*

This example is adjudicated in the same manner as if F Eng were attacking F Bel with support. It is a standoff because the two countries are equally supported. In Example 1 F Eng is dislodged, so this example cannot be adjudicated in any other manner. The convoying army is not ordained by the Rulebook with Extraordinary prerogatives.

FRANCE: F Bre-Eng, F Bel S F Bre-Eng

Here the convoy succeeds and F Bel is dislodged. Nevertheless, the support of F Bel is valid according to Section XII, Paragraph 5, even though Section X states that a dislodged unit cannot give support. Mr. Calhamer affirms that he did intend Paragraph 5 of section XII to be an exception to Section X.

6. ENGLAND: A Lon-Bel, F Nth C A Lon-Bel, F Eng S A Lon-Bel, F Wal S F Eng

FRANCE: F Bel-Eng, F Bre S F Bel-Eng

Again the convoy succeeds and F Bel is disledged, but note that the support of F Eng is not cut by the attack of F Bel.

7. ENGLAND: A Lon-Bel, F Nth C A Lon-Bel, F Eng S A Lon-Bel, F Wal S F Eng

FRANCE: F Bre-Eng, F Bel S F Bre-Eng

All moving units fail and the support of F Eng and F Bel is cut. The last four examples involve a guessing situation between the combatants. If England convoys via F Eng, France must attack with F Bel; if England convoys via F Nth, France must attack with F Bre.

## Part 2

The adjudication problem of the paradox discovered by Anthony Pandin is attributed to a flaw or ommission in the logic of the rules. Each of the rules changes hithertofor proposed to resolve the paradox is unacceptable, either being completely arbitrary, not conforming to the logic and intent of the Rulebook, or severely limiting the tactical flexibility of Diplomacy. My proposal for solving any paradox withstands each of the preceding objections; most importantly, it does not affect the adjudications of any other convoy orders:

If a convoyed army's attack would affect the position of any of its convoying fleets, the army may not move.

In particular, this rule extends and clarifies the basic concept of Section XII, Paragraph 5, in that it not only prevents a convoyed attack from protecting the convoying fleets but also prevents it from harming them as well, because a convoyed army's attack may not cause the dislodgement of any of its convoying fleets. Whenever the convoying fleets cannot be dislodged, my rule does not apply.

Under this proposed rule, the adjudication of Pandin's Paradox is:

ENGLAND: A Wal-Bel, F Eng C A Wal-Bel, F Lon S F Eng

GERMANY: F Hol-Nth, F Bel S F Hol-Nth

RUSSIA: A Nwy-Lon, F Nth C A Nwy-Lon

A Wal-Bel does not move because if the convoyed A Wal is allowed to cut the support of F Bel, F Nth is not dislodged and A Nwy cuts the support of F Lon, which would dislodge England's F Eng. If the convoy of A Nwy is considered first, A Nwy still

does not move because it causes the dislodgement of F Nth and in order to resolve the adjudication, the rule must then be applied to A Wal.

Consider other examples in which the proposed rule applies:

1. ENGLAND: A Lon-Den, F Nth C A Lon-Den, F Ska S A Lon-Den, F Swe S A Lon-Den

GERMANY: F Den-Nth, F Hol S F Den-Nth

RUSSIA: A Nwy-Lon, F Nth C A Nwy-Lon

FRANCE: F Mid-Eng, F Bre S F Mid-Eng

If the convoyed attacks is permitted, it dislodges F Den and breaks the standoff of the German and Russian attacks on F Nth. My proposed rule, therefore, does apply, disallowing the convoyed attack. This restores the standoff, preventing F Nth from being dislodged. If F Hol attacks F Nth and F Den supports, the convoy succeeds because support of dislodged F Den is not cut and the German/Russian standoff is not broken.

2. ITALY: A Rom-Tun, F Tyr C A Rom-Tun, F Nap S F Tyr, F Alb-Ion, F Adr S F Alb-Ion

TURKEY: A Gre-Nap, F Ion C A Gre-Nap, F Tun S F Ion

FRANCE: F Lyo-Tyr, F Wes S F Lyo-Tyr

There is nothing in the Rulebook covering this problem. If you begin adjudicating with A Rom-Tun, Turkey's F Ion is dislodged by Italy's attack and F Tyr holds. If A Gre-Nap moves first, France dislodges Italy's F Tyr and F Ion is dislodged. It's mundane to reduce Diplomacy to a level where a Gamesmaster is unable to resolve the orders unless he flips a coin to choose which army kicks off. My rule is applicable: The armies may not move since ther affect the position of their convoying fleets.

## COMMENTARY

It is with great regret that I am forced to note that Rod Walker is once again attempting to create bad blood in the Diplomacy community.

In ERRHWON 83 he bemoaned the fact that THE DIPLOMACY ASSOCIATION had written articles on stalemate positions, and then suggested that although the articles were "unfortunately" copyrighted, publishers could go ahead and reprint the material as long as they "paraphrase" the information! This shows absolutely no concern for the rights of the authors of those articles who compliled the original information and then took the time and effort to present their findings to the Diplomacy community, asking for nothing for their labors! I could see the point of his argument if the articles were published in only one 'zine with a limited cirulation. But they are disseminated throughout the entire community by THE DIPLOMACY ASSOCIATION! The articles originally began in Wazir, the publication of TDA. Then the decision was made by TDA to discontinue publishing the articles in Wazir and instead offer that material formerly reserved for Wazir to the entire Diplomacy community by circulating the articles to a number of publishers. In that manner, not only would members of TDA benefit, but also non-members. At no time did or does TDA

charge publishers for the right to reprint or publish TPA-sponsored articles. As far as I know, even Mr. Walker could have published the articles merely by asking for them!

Unfortunately, advising publishers to bypass copyright laws was not enough. In EREHWON 85 he published a TDA copyrighted article "The Boardman Numbers," without asking or receiving permission to do so. Why? To correct errors in the article, according to his statements! So why didn't he merely write a rebuttal to the article? He did, on 4 February 1975, and sent it to me for publication. It would have appeared in #78, except that EREHWON 85 came out (20 February 1975) before the March issue of ATLANTIS, making his rebuttal redundant.

For any publisher who might seriously consider following Mr. Walker's example and reprinting copyrighted material without waiting for permission, I have heard that legal proceedings will be started by the author of "The Boardman Numbers" against Mr. Walker.

I don't know of any publisher that can be so hard up for material to print that he will take the work of another without permission....

[Of course, opinions contrary to mine are welcome and will be reproduced if at all possible.]
