Within days of announcing the formation of "G" we had a complete roster plus some. I'm extremely glad to see some new faces -- three, in fact -- and one new to BARAD-DUR, but not to GB series play. For the record, 11 people applied as of this writing. "J" should be easy when the time comes....

Game fee is in brackets after your name. If you want the 'zine air mail, it's 31,00 more than the stated price, Payment is due with or before your Spring, 1901 move orders, CHECKS SHOULD BE MADE PAY-ABLE TO JACK L. CHALKER, please. It's hard to get a bank to recognize a sheck made out to "MIRAGE," let alone "BARAD-DUR."

Countries were on a first-come preference basis. Stand-by moves will be made during 1901 by anonymous experienced players if a nation is in danger of not building at all due to non-moving (under the theory that, while players can be replaced, missing an *01 build will alter the course of the game and will be detremental to all players). After 1901 - well, no stand-bys at all, If you miss 1 move, your units stand and do not support but may be supported. If you miss 2 consecutive memes (i.e. a spring & fall or a fall and spring) -that's moves, not builds & retreate -- you will be considered to have resigned and will be immediately replaced.

My interpretations of the rules are often controversial. If you are ever in doubt as to how I would rule on a given situation, write me beforehand detailing the question and I will answer in confidence

-- whether theoretical or resi-game situation(s) are used.

Moves must beach me by the specified day and time noted as DEAD-LINE for all games. I am also not responsible for moves lost in the mail or garbled in telegrams. I am further NOT responsible for any move not submitted in writing or, if submitted vocally by phone or in person, confirmed within 7 days or less in writing, although every care is made to get the moves correctly and keep them available. I can virtually always be reached by phone after 4 PM (Eastern time) on the deadline date. If not, give the move to whoever answers the r Scriphone...

No revisions in moves are allowed. The first set of moves to

reach me stands.

Camesmaster errors must be appealed within 7 days of deadline or they stands

Playersmare urged-to submit phone numbers (including area codes). in case of emergencies. Otherwise, not responsible for lost moves.

The only rule on propaganda is -- THE SHORTER THE BETTER. Never include moves in the context of a latter. Itemize your moves in full, then write the letter or propaganda underneath. For units moving to or from multiple coastlines, the coast must be denoted (abbreviations: (SC)=South Coast; (NC)= North Coast; (C) = convoy; (S) = support). The GM will recognize these. HOWEVER. moves made

to or from Norway, the North Atlantic, and/or The North Sea MUST be written out in full to avoid the "NOR" or "NORTH" confusion.

Deadlines are 14 days apart, on Fridays, 9 PM. Eastern time is

used -- daylight time until the end of October, then standard.

If you move, send CoA and when effective at least a week in advance of the deadline date. If you go on vacation, send us your vacation address & dates effective. If a college address, be certain that you give home address & dates effective well in advance.

Your first game in BARAD-DUR or ORTHANC is 34.00. That is your total fee for 1st class surface subscription for the duration of your game. 31.00 more in BARAD-DUR for air mail. If you are in a postal game run by the National Fantasy Fan Federation Cames Bureau (i.e. a GB- game) additional games are \$2.00 in either magazine.

SUMMER RETTERTS WIN BE CONCURRENT WITH FAIL MOVES!
SPRING, 1901 MOVE DROERS AND CHECKS ARE DUE ON OR BEFORE FRIDAY, NOVEMBER 18, 1966. This allows you 28 days for initial Diplomacy. You are then on your way every 2 weeks, effective that date. You are in GB-1966-G. Please remember to put the letter "G# at the top of ALL moves, and pasferably also on the outside of your envelope. NEVES send moves by postcard. It's unreliable, usually illegible. In order to sustain your subscription to BARAD-DUR for the duration of the game you must continue to submit orders until the Gamesmaster t , $t^{1/4}$ declares the position unplayable (usually 1 remaining unit) and may, $t^{1/4}$ of course, continue submitting until eliminated. The answer's difficult. I think my ruling rules out all such gimmicked actions, but I'd like to see a full set-up involving the support situation which you mention in order to make a fair evaluation.

However, as far as I can see it, you state that,

if X attacked Y, and another unit of Y supported X into Y, it's of no effect? No, the answer is that Y's support of X is of no effect.

However, the ruling you cite -- "An order to move with support against a unit belonging to the same country as the moving or supporting unit, is of no effect" is the precise rulebook wording upon which I based my ruling in the C game fracas, and the same rule upon which I base my decision this time re: Austria and Turkey in XF.

Now there's my reply, John McCallum -- though darkest Diplomacy with rulebook and rationals. Comment?

I have located the slip of paper with the retreat, and feel certain that I wouldn't have used a separate piece of paper for the moves, but, although in this case I tend to think that I'm not quilty, I really do not know whose memory is correct -- Jerry's or mine. France is still playable, but Jerry would like to petition for a rostart from Fall, 1902, allowing your revisions and his moves. It will take 5 out of 8 of you to do so, so please vote.
Otherwise, next move I shall ask Jim Dygert to take over

I was almost ready to reverse myself -- even had an apology on stencil -- but then I saw how the arguments against my rulings were invalid.

The rules state that an attack is made solely on a province, not on a unit. This means that you can have either of the two alternatives without too much of a problem. However -If a unit stands, it supports itself and may be supported.

If a unit moves unsuccessfully, it can NOT be supported in the

province from which it is trying to move.

The rules state that an unsuccessful moving piece is bounced back, and must stand and support itself. Thus, the fact that a backup attempt had been made with a 2-factor going into the province is irrelevant. The 2-factor attack can not be legally accomplished, since a bounced unit must stand and support itself.

John McCallum writes that he hasn't commented on the question because "I am too shocked by this flagrant violation of Calhammer's

own rulings in RURITANIA."

D.K., fine. But I don't recognize the RURITANIA ruling and for one simple reason: as John Boardman himself told me, "The AURITANIA Ruling can not be accepted as a part of the rules, since Calhammer was himself one of the players involved and he ruled in his own favor. 4 If Mr. Calhammer should desire to write the EURITANIA ruling into the rules by specific example, I would feel bound to follow it on games begun after the new rulebook appeared. However, if he continues to take no official position, I will stick to my guns. I feel my interpretation to be the only possible interpretation under the rules as they now stand.

Hal Naus notes in A DROIT that he would have ruled the same way

Don Miller feels that, in the Russo-English situation, F Denmark is eliminated but the province of Denmark remains vacant and English.

Under Calhammer's rule, as expressed in RURITANIA, the situation would have been a standoff, ignoring entirely the unit in Denmark -- which seems weird since his own rules state that the unit in Denmark has a duty and obligation to support itself.

That is the major reason why I take the RURITANIA Question with a grain of salt.

Richard Shagrin (Rm. 356, Haggett Hall, U. of Washington, Seattle, Wash., 98105) has a unique commentary: "Once again Richard Shagrin...to the rescue. Now for the definitive answer to your problem (Turkey-Italy fleets). "An order to move with support, against a unit belonging to the same country as the moving or supporting unit, is of no effect." -- Rules of DIPLOMACY, P.4, in the middle, just above ATTACK. Your analysis of the situation is, then, correct and exactly by the book ((and so McCallum and Calhammer both are in biolation of the rules if they rule standoff, while I'm by the book, as I've always claimed. JLC)). In the hypothetical Turkish-Italian situation, there is some faint, irrational prejudice that tells me that the Turkish move order is "of no effect"...and thus Italy makes it. But this way madness lies. Assume a 2-2 standoff. The clever rulebender lets one of his units support his opponents move -- presto! the move is "of no effect" and his unit's moves succeed, where
