Rept. Rights Dept.

A federal judge said he was "outraged" to find that trustees of a \$3.75 million fund to promote sex equality in the world's largest bank were using the money to send women on African safaris and to French cooking schools. "I am absolutely flabbergasted," said U. S. District Judge Charles B. Renfrew. The program was set up by independent trustees to help women employees of the Bank of America achieve higher status positions.

Judge Renfrew told attorneys for the trustees to halt the practice of using funds for such things as Caribbean junkets. He cited the case of a \$2530 award to Eileen Katz to visit the wine countries of Europe and take a week-long cooking course at the Cordon Bleu school in London. Another woman was granted \$1400 to go on a historical tour of colonial America with stops at New York and Washington. Judge Renfrew said the women with the greatest ability and skill in filling out applications were awarded the ill-travel grants. "The very women you are trying to help are the ones who will get the best," attorney Robert W. Hirsch told the court.

Bureaucrat at Work Dept.

Jubal Hale admitted he's a bureaucrat with little to do. So he spends his working hours reading and listening to Beethoven in his office. Mr. Hale said it's not that he doesn't try to earn his \$10,693 a year salary as executive secretary of the Federal Metal-Mineralic Safety Board of Review. It's just that the board has never had had anything to review in its four years.

Mr. Hale was contacted by a reporter after Rep. Ken Hechler (D-WV) charged in a House Appropriations Subcommittee meeting that the board was "a totally useless, toothless and do-less government agency which has never earned its pay." Rep. Hechler called for the board to be abolished. Mr. Hale said he doubted any objections would come from his office if Congress did just that. "We have been extremely candid with Congress," Mr. Hale said. "Our annual reports are clear and concise. We have had no cases."

The five member board was set up to hear appeals from non-coal mine operators ordered to shut down by the Mining Enforcement & Safety Administration (MESA) as unsafe. A MESA spokesman expressed surprise that the board was still in operation. "I thought it had been abolished some time ago," he said.

There were 1993 closure orders last year but not one was appealed to Mr. Hale's board. Rep. Hechler said that mine operators have another avenue of appeal through the Interior secretary.

He described a trip to the board's offices last week. "The door was open, the telephone was off the hook, and nobody was around," said the congressman. "The coffee-making equipment was elaborate. A large stereo set was in the office with Beethoven records stacked high." Mr. Hale said he was visiting the Interior Department and the secretary was home sick when Rep. Hechler visited, so no one was running the office. He did not dispute Rep. Hechler's description.

AMERICAN PIE

How many times have you said, "It's as American as apple pie," without realizing that it made you sound like an idiot? The reason people giggle up their sleeves when you use that expression is that apple pie is not really American at all! Thus you might as well say, "It's as American as sauerbraten mit kartoffelklossen." To atone for your former ignorance, you should memorize the following historical facts about apple pie, extracted from A. LaMode's monumental Histoire des Tartes à la Doux, Co La La (Ste. Vache, 1838). By quoting these passages at dinner parties you may even acquire the reputation of a gastronod.

Apple pie was invented by a Chinese emperor of the Sing Sing Dynasty (949-953 B.C.) to please his wife's dog, Fai-Do. This first pie was something of a mess, containing not only the flesh of the apples but also their skins, seeds, cores, stems, and bits of twigs and bark, as is still customary in New England. The introduction of apple pie to the Occident is due to Marco Polo's nephew, Water Polo, who in the fourteenth century set out to discover Paraguay, took a wrong turn at Hog Island, and wound up in Shanghai. On reaching port Water Polo disembarked, politely made a port bow to the inhabitants, and inquired the way to the Port Authority. The perplexed Shanghaiites conveyed him to the Imperial Palace for an audience with the reigning emperor Chow Down. On being conducted into the imperial presence, Water Polo began a prepared oration in Spanish, extending lavish salutations to His Imperial Majesty from the Western world and hoping for improved trade relations between Italy and Paraguay. The emperor, who knew only a few Spanish phrases like "frijole" and "closes el windo," ordered the garrulous stranger decapitated. Fortunately for Polo, the emperor's daughter Lo Down interceded for him, and Chow Down not only rescinded his order but invited the visitor to a banquet, where Water Polo first encountered Bing-Bang Bzu.
