

#### DIPLOMACY WORLD FAKED

Getting two issues of <u>Diplomacy World</u> in the same week was indeed a big surprise, especially since both of them were marked as issue 27. I have checked with Jerry Jones to confirm that the one with the green cover is indeed a fake. It is a splendid job and really looks genuine. Even the mailing envelopes were faked.

Yes, I was taken in by it at first, but there were just too many things that weren't right. Like Mark Lew being the top rated player in the update of the Dragon's Tooth Ratings. Then the real issue, the one with the gray cover, arrived and I knew it was a fake.

The fake issue is purportedly green because it is a theme issue devoted to "How to play Italy." The feature eight page article of this theme is really full of far out and weird strategies for playing Italy. The authorship of this bit is credited to Dave Grabar; if any other name had been penned on it, it would have been immediately obvious that it was a fake. There is also a non-Diplomacy related article on Irish humor (is this also in keeping with the green cover?) is attributed to Michael Mills. Most of the jokes contained in this article are quite crude or vulgar, however.

By comparison, the real issue of <u>DW</u> is rather drab and uninteresting. An article on the history of variants by Fred Davis is interesting and there are three good articles by Mark Berch (a new variant and two brief strategy bits) but from there on it is downhill. An article on houserules by Linsey and one on absurd convoy situations not covered by the rulebook (situations that have never and will never appear in a real game) by Larzelere are both a complete waste of print.
