Dear Jim-Boob,


Time to respond to all the mindless trash you've been sending me. Oh, that was a game? Oh.

### **Boob's Corner**

This issue is pretty short, so the postage to Brian Dolton is held to \$0.44, but I should fill this space... If anything succeeds at generating the national debate on monopoly power that should be part of the upcoming US presidential race, I predict it will be the recently concluded USFL-NFL anti-trust trial. After all, Jack Kemp (former quarterback) and Bill Bradley (former basketball forward) both will be running for president in all likelihood, so what could be a better way to start the debate? The jury trial result made so much sense it's hard to believe that anyone is questioning its rationality. Fairness, though, is another matter... Of course the NFL is a monopoly, as are all sports leagues. Not many people know this, but major league baseball has a specific anti-trust exemption written into one of the anti-trust acts that prohibits suits like the one brought against the NFL. I believe baseball is the only industry that specifically is allowed to engage in monopolistic behavior (keeping control of the location of franchises is the largest

element in the value of sports teams), but the others have de facto permission as well. The USFL was not granted damages by the jury in the recent trial because of their own mismanagement and that may be a just decision under the circumstances; however, the NFL is a natural monopoly and the argument exists for them to be regulated just like a public utility (e.g. electric companies). That's what people mean when they say that the USFL never had a chance competing directly with the NFL. The NFL quietly has tried to get their own anti-trust exemption, but has never managed to push it through Congress. While all sports teams milk the citizens of the communities they play in by getting them to subsidize the construction of stadiums, they just go on earning profits without competition. How different is that from making communities bid against each other for the "best deal" to give to GM for a new plant in th community. Lots of interesting questions...whe would Mr. Kemp say to all that?
