SUBS EXPIRING: #75, Howe; this #76, Kirchner; #77, Olsen, Becker, J. Albrecht, Perlmutter, Smyth. This high rate of publication does tend to take its toll, doesn't it? On the other hand, it keeps sub checks comeing at a fairly decent clip, and since it costs \$12 in postage alone to put 1 issue in the mails (and rates are going up in 10 more weeks), it is just as well. So far there has been a certain amount of 'subsidy' via old company envelopes that I used at a discount; these are running out fast, and there won't be any new ones (unless I find a cache of oldies in a nook somewhere someday), so that means that lil' ol' me is going to have to start footing 100¢ on the dollar for postage shortly. The present rates seem high to me, but as Mark Berch brought up in a recent DIPLOMACY DIGEST editorial, the effect of all these new zines (and some old) who charge fees in the 55-70g range each to come close to their actual costs will be a move toward fewer zines subbed to by each individual. No problem for me, of course, since I'd sooner handle a lighter load and, BB would in most cases be one of the last zines that a given non-player would drop. However, the HOBBY will suffer, as newer zines will face a tough uphill fight to gain many paying subbers (or even traders) beyond their immediate players when they have an as-yet-unproven track record and quality level to offer vs a \$6/10 issue sub rate, ignoring gamefees. It will tend to push people into only subbing to the zines they MUST to play in, limiting their exposure to hobby happenings and trends, while making it harder for new and unestablished zines to make much headway into circulation. Eventually, of course, people will get used to high fees just as they have adapted to high inflation, unemployment, crime, bussing, and Democratic rule. However, if it takes a year and a half to two years in a hobby where the average stay is about two years, we could face a virtual Dark Ages ahead. What if all that came out the "other end of the tunnel" were such hobby torchbearers as GRAUSTARK and LE FRONT? Quite an odd hobby we would seem to have, if that were the 'core' around which to rebuild ...

Speaking of CRAUSTARK, (something I rarely do), the latest issues that I received had an odd but interesting offer. If any of you put any hope in the minor fringe candidates, publisher John Boardman makes this offer: "Send me \$5 so that it arrives on or before Nov 3. If the combined vote for Anderson, Commoner, and Clark in any one of the fifty states is enough so that, if cast for one candidate, it would enable that candidate to do as well as second place, you will get an entry in a postal DIPLOMACY or CONQUISTADOR

Regarding Kathy's name- Egotism? Maybe. But thru VOD 26, you were still printing her name and she resigned from her game in #15 and from the zine in VOD#20. Name one descent issue you've put out, in fact, I defy you to name one issue in the last 12, up to $\mathtt{VOD}^\#_2\mathtt{26}$, in which her name has not \mathtt{appe} red.

On most of the rulebook rules, common sense prevails. However, by your admission, the rulebook is ambiguous. If this is true, how can you state that you know "more about them by a substancial margin", than me? How can you possibly know more about a rule than anyone, if by your own definition, that rule has more than one meaning?

Let me clear up one more "AMBIGUITY", that BL keeps hinting at. These letters are written by John only, not John and Kathy as he leads everyone to believe. Comments to me should not include your "slurs"of Kethy. After all, she didn't say these things, I did.

Speaking of which, who is "honeypie" and who is "honeybunch"? Must be that girl Bernice you had mentioned when you were down to visit Kathy and I in March.

It sounded like a real "Love Affair", back then.

Now, on to Bruce Linsey's claim that I can't prove my charges. He states the xeroxes are real, not phoney, ask Mark Berch. I never said the xeroxes were phoney, I said the proof was. And that proof, from VOD#14 is quotes from one person labbeled "Exhibit A". The difference in the 2 letters is that in one letter, it states HEARING IT THROUNG THE GRAPEVINE, while in the other it states OVERHEARING IT WHILE THERE. Overhearing the conversation is explaining how it was heard thru the grapevine. The grapevine can be any source, that is informal. A phone call is as informal as you can get. (check with Webster)

Next we come upon "Exhibit B". One slight thing some people might overlook when reading this- the 2 letters were written by *2 Different Feople", not one. Attacking me in VOD will only prove my point moreover, that Bruce Linsey can't handle any kind of debate or discussion, regarding himself, on NEUTRAL GROUND.

AN OPEN LETTER TO THE DIPLOMACY HOBBY

Yes, that word was "Hobby". Isn't it about time that it resumed that status? The subject of this letter is the Bruce Linsey / John Caruso feud, which threatens to move Diplomacy from amateur zines to federal litigation.

When you, I, or any Dipper entered the postal hobby, we did so because it seemed a creative and challenging way to enjoy a game we liked. It allowed us to share entertainment with intelligent people like ourselves, rather than read "Mad" or listen to our roommate, Melvin Mugwump of Grinnell, Iowa, play his disco records. So what does a Fall 1980 novice see? Diplomacy games? Diplomacy strategy/tactics articles? No, the sample zine he receives has several pages devoted to charges and countercharges of persons who likely have never played in that zine. No, he convinces third-party publishers to print his side of the story, complete with plenty of accusations. Such "Let's make this public" articles have, to date, taken up large amounts of space in The Voice of Doom (Linsey's), Whitestonia (Caruso's), Passchendaele, The Brutus Bulletin, Retaliation, Murd'ring Ministers, and probably others that I haven't seen. Now, both parties (acting on the principle that each man is his own master) circulate releases, detailing charges and making personal attacks, to several dozen other publishers, expecting them to devote space to these 'mutual critiques'. Obviously, these two gentlemen do not contribute all of the reading material. Mr Caruso's cohabitant Kathy Byrne is sure to write some comments about

Mr Linsey's GM'ing habits or personal ethics, and often is herself responsible for the controversy. Others, involved and not, chip in their two cents, and there is an occasional "Y'all shut up!" letter like this one.

Let's face it. Other than John Boardman, no one lasts forever, and new people take their first look at the hobby every week. What's our image going to be among them? Is "You're an immoral liar!" any better than "Konrad's a fag" or "3 of my GM's folded last month"?

Come on, guys. Let's put this into perspective. Nobody's talking about pushing the little blocks around the board anymore -- they're threatening to denounce their 'enemies' to newcomers by means of the Novice Packet. For the good of the hobby, put down the slingshots, or your players will rebel and condemn you. Give that kid in the book store picking up the box right now his chance. Peace.

NARCOTICS & DANGEROUS DRUGS REVIEW -by Anonymous

The first item is marijuana. I'll only get into the basics here:

HOME GROWN "MEAN GREEN": Generally, refers to most pot grown in the good old US of A... Like most other US products, it's inferior to the foreign version. If you pay for it, you're either naive or a sucker. Identifiable by it's light green color, grainy texture, and sparse white seeds.



PROBLEMS are evident by the rate at which you will be receiving #75 and 76. If you think it is inconvenient for you to get two dipzines within a week, let me tell you, it is not a joy to put them out either. One way around some of this is to REDUCE the size of the material. I could do masters up on 14" long paper, tape two side by side, and then reduce the whole 11x28 equivalent to a single 82x11 like the "Discussion page" in #75 was done, or part of the 79Iid wrapup. However, I find a lot of that hard to read, and while a DIPLOMACY DIGEST of 2 or perhaps 3 folded sheets isn't too bad, what would you do with 11 sheets of it? On the plus side, I could go to publishing only once a month, which would allow your subs to last leonger, to say nothing of your getting 40 pages of material on less 12 sheets. My only question is, is it really worth it? I for one am inclined to say no, but putting together two fat issues in very short order isn't something I want to do all the time either, and if it comes to considering cutting out some stuff to fit the average-dipzine mold, I for one would sooner fold. I didn't start out to put out just another dipzine, and I have no intentions of carrying on as just another dipzine. For now I will run what I get as I get it, just like always. However, if any of you have some ideas, I would be glad to hear them.

(Note to new folks: this doesn't mean that any game you're in here is in any danger. Even if I were to close up shop instead of simply seeking possibly superior formats for this thing, your games will run to completion no matter what.)

Speaking of new folks, I need to welcome aboard a number of new and renewing faces. Among these are Norm Schwartz, Briarwood NY; Dan Stafford, Columbus, Ohio (pretty town. I used to drive through it twice a week for a year...); Jim Vaughn, Leominster, MASS (sorry, I've never been beyond NYC-Albany-Rochester, so no plugs); Bobby Stephens, Fort Worth; Bruce Stewart, West Hill, Ontario; and resubbers David Carter and Steve Heinowski.

Some publication information: current print run is 66 to allow for samples. I'm considering letting that drop to 60. 58 issues are committed to either subbers, trades, or complimentaries. Trades constitute 12 of them; 3 shaky complimentaries may soon go to 6 if some/all my GCMs opt to let their paid subs lapse. They will take priority over the other 3. Complimentaries go only to people who seem to be interested IF there are extra copies left. This will not always be the case. Personally, I consider a sample request more important than a complimentary: sample requests from the middle of the country have about an 80% chance of turning into a \$5 check in hand, so I'm not letting them go, and there have even been people on the coasts who like this thing. Since my own costs will be going up even aside from imminent postal increases, paying customers need to be a very hefty % of the audience. TRADES are sometimes a good deal, though these months when I put out 3 issues make that not beyond question. I suspect that the start of next year with its higher rates will cause me to cut about a third of them. I don't expect you to put out 2 or 3 2oz issues each month to "match" me, but frankly, a lot of zines tend to slide into nothing but game results/"sorry-I'm-late and a quick "See you next month" . Even allowing that my copying and labor are basically free, the postage alone means that I'm paying, or soon will pay, 60¢ for your zine. Cheaper for me to write you a check, isn't it? Right now I operate on the assumption that the "marginal cost" of "one more issue" is less than what I'd have to pay for your zine. That is coming into question.

SOME SERVICES: I am still able to make sets of labels for you from a free master form(s) I can provide for only the cost of postage to mail them to you, basically. A couple of zines use this as their regular system for saving work. I will continue this until the ever-increasing chickenshit around this office forces me out of the xerox room altogether, which will be about the same as out the door. Also, copies of the old Novice Packet that Craig Reges put together are still available for the asking, though two stamps would be appreciated. I don't have too many left, and hopefully Linsey's will supercede this, but for now, there are still a few there if you want one or know someone who might benefit. Sets of my own completed mailing labels are available for the asking, in case you want to send samples or a fake or whatever. The number that appears on your label is the number of the last issue you will receive. I don't plan any new games for the forseeable future, as I hope to concentrate on just publishing without deadline interruptions, so if you're waiting on a game here, get in with one of these GCMs I have. I intend to let THEM do all that sort of thing once 79IZ, 8OD, 8OLji, and 78Tid are done and gone. Which will hope-

fully be soon.
