Dear Ken:

Thanks for your letter of 22 October. My position on the KGO matter is detailed in ZIMIAMVIA 4, which should have been enclosed with the update forms you received. There is not much I can add to that statement.

However, in brief, the KGO list is nothing more than DIPLOMACY WORLD's long-standing "Need-a-Game" list, which he was made editor of by Jerry Jones. He was removed from that position for delisting Don Del Grande without any proper investigation to determine if any significant wrongdoing was involved, without informing Don he was doing so, and without even discussing the nature of the charges with Don. Considering his gross violation of Del Grande's rights in this matter, his insistence that he (Sacks) has any rights is laughable.

By the same token, since he is going to use the "KGO" title, and maintain a list, the resulting confusion should be minimized. Therefore, as noted in ZIMIAMVIA 5, enclosed (cont. next page)

...(cont. from page 5), I will be using a different name for D.W.'s list of game openings. Be that as it may, DIPLOMACY WORLD will resume the independent compilation and publication of game openings, just as we did under Walt Buchanan and Conrad Von Metzke.

I am urging all GMs to keep current in both lists. I don't know what purpose will be served by listing with Sacks, since the novice pipeline is served by our list. However, perhaps he has some coverage that we don't. It won't hurt to stay current with him as well. I doubt he will send us a copy of his listing, although he will continue to receive ours so long as he is mentioned in it.

If Sacks sends you a copy of his list, and you wish to send it on to me, I would like to see it, just as a double-check on the info we have. If he threatens people who update with our list with reprisals, I definitely would like to know about that. Bob may declare that there is only room in the hobby for one such list. Ordinarily I would agree. But what we have at the moment is an honest list (ours) and one of questionable integrity (his).

Combining these two lists back into a single one is possible, but only if Sacks agrees to certain minimum conditions. First, he must accept DW's proprietary interest in the game openings list. Second, he must provide adequate guarantees against any repetition of his arbitrary and discriminatory action against Del Grande. Third, he must cease putting political editorials and commentary in the list.

It has been my experience over the years, that Sacks will not cooperate with, nor provide information to, people who oppose his schemes. intricate political schemes. I am therefore disinclined to put myself in a position where I will have to be involved with him. I therefore regard the conditions above as absolutely minimal (and I have others which might be negotiable) and I will not compromise them.

Anyone who wishes to mediate the situation is welcome to try. My own preference is to make any resolution of this problem part of a general resolution of numerous grievances I have regarding Sacks, including his long-standing refusal to provide information repeatedly requested by NAVB. Under no circumstances will I enter into direct communication with him; I have for the last time endured the frustrations of evasive, crabbed, rude, and imperious little notes full of self-serving distortions of fact and outright lies. Frankly, if I never hear from Sacks again, I will be content. I have tried to work with him for years, something his methods and attitude have rendered fruitless and ultimately impossible. I would have gladly maintained the KGO/DW connection if Sacks had not blatantly continued to use it as a political soapbox despite objections and had he not removed a name from the list on the basis of charges he had not even communicated to the 'accused', much less investigated and substantiated.

Equipment Changes:

The board of course! Use the Middle Earth map given on the opposite side of this page. I would suggest that you reproduce it on a larger surface, of course,.

Rules:Changes:

CONVOYS: Regular convoy rules may be used, however, the Army/Fleet piggy-back rule is suggested.

SUPPORTS: Regular support rules are also applicable to this variant, but you might find that the 'supported-support-cannot-be-cut' rule works better. That is, a support is only cut if it is attacked with equal or greater strength.

OTHERS: None, except with regard to supply center control, as noted below.

HOME CENTERS AND POWERS:

LINDON: AFar Downs, one fleet and one army between Grey Havens and Eryn Vorn.

HOBBITON: AHobbiton, ABree, AOld Forest

SARUMAN: ATharbad, ADunland, AISengard

ROHAN: FLond Daer, AHelm's Deep, AEast Emnet

GONDOR: FDol Amroth, ALamedon, choice Minas Tirith and Pelargir

HARAD: FUmbar, AFar Harad, AKhand

MORDOR: AMinas Morgul-choice, ABlack Gate, ABarad-Dur

RHUN: ARhun, ACarnen, ANorthern Wstes

RHOVANION: FOld Ford, AEerebor, Athranduil

LOTHLORIEN: ARivendell, ALorien, FCaras Galadon

In addition, the following centers may be used to build in once owned by the specified powers: Lindon: Minhiriath, Beleriand; Hobbiton: Forochel, White Downs; Saruman: Fangorn, Minhiriath; Rohan: Fangorn, Druwaith Iaur, Celebrant; Gondor: Dunharrow, S. Ithilien, Tolfalas, Druwaith Iaur; Harad: South Gondor, Harad Road, Tolfalas; Mordor: N. Ithilien, Dol Guldur, Harad Road; Rhun: Iron Hills, Esgaroth, Dol Guldur; Rhovanion: Dol Guldur, Esgaroth, Iron Hills, Arnor; Lothlorien: Celebrant, Fangorn, Dol Guldur, Arnor. Finally, a power may build in the home centers of another power if that power is eliminated, and all of its original home centers are controlled by the power that wishes to build there. A power may never build in another power's "bonus" building centers.
