Happy New Year!

On Tuesday January 13 the 70th session of the Texas Legislature convenes, with a projected deficit of \$5 Billion ahead of them. I still don't understand the deficit being so large, since the total revenues only dropped \$400,000 from the last two years, but if the comptroller says it, it must be so! On Wednesday January 14 I start the second year of law school. This is going to be fun, having both going on at the same time.

My courses during this semester are Constitutional Law (according to the supreme court, not Ed Heese), Business Associations, Federal Income Tax, and Secured Credit. Lets talk about statutory law! The trick is to slip an extra unit onto the board when others aren't looking, or in postal play, to trick the GM into giving you an extra unit. If anyone ever tried that in a friendly FTP game, I would stop playing and probably not play with that person again, if that happened in a tournament game, I would insist that the perpetrator be disqualified and removed from the game.

Now some of you argue that all is fair in Dip, and to a degree that is true. I draw the line at the mechanics of the game. Lying to other players is part of the game, and has to be







I must admit that it does not take much to destroy my faith in Ronald Reagen; whatever confidence I had in his Presidency ended about a month before he took the oath of office. Still, watching him squirm like this has not been pleasant. I guess it is unavoidable; the last few Republican administrations have been marked by generally stupid policy, and the sacrifice of American interests in the name of anti-communism.

The problem is that this hasn't been the first big goof Reagan's people have made; just the first one they've been called to account for, the first one so blatant that no amount of teflon can cover it up. Good men have lost their lives because of Reagan errors in Lebanon, and think of how many people have died in his pipe-dream war-by-surrogate in Nicaragua, on both sides. And think of how the American standard of living has been affected by the corporate shenanigans encouraged by this administration. And don't forget which President has ushered in the routine \$300 billion deficit. The Reagan administration was a failure from day one; it's just taken this long for it to show.

The problem is there isn't really anything to be done about it. We're stuck with two more years of Ronald Reagan, although how he can govern effectively with a Democratic Congress and all those chinks in his armor is beyond me. We had our shot two years ago. The Democrats had a chance, and they blew it by nominating the one man who was guaranteed to lose the election. We will have to endure two rudderless years until we finally get around to electing a President who can actually work.

My chances of voting Republican are worse now than they ever were.

<<OK, no more Mr. Nice Guy. Point by point: What "generally stupid policy" are you referring to in the last few Republican administrations? The Domestic economic policy of Reagan that brought us out of recession to the strongest non-war economy the country has ever had? The stupid foreign policy of Nixon that opened China and resulted in the first significant arms control agreement with the Russians and eventually ended our involvement in Viet Nam? The stupid way the Ford dealt with a hostile Congress by vetoing measure after measure that would have gutted the Presidency, quite possibly saving the separation of powers and the Presidency by doing so?</p>

Maybe we should discuss the brilliant policies of the Democrats. Kennedy and his Bay of Pigs, LBJ and the escalation of the war in Viet Nam, or Carter and his combined failure in both foreign and domestic affairs by abandoning our allies and causing the worst stag-flation we have ever had.

I didn't agree with Nixon's economics; I disagree with a lot of Reagan's foreign policy. But I haven't seen a Democrat candidate for President in my lifetime who was worth voting for. Apparently the American people tend to agree with me, because since Truman, the Republicans have won six out of nine Presidential elections. Deduct the anti-watergate vote in 1976 for Carter, and it would have been seven out of nine.

Yes, President Reagan has made some mistakes. I wouldn't have put the Marines in Lebanon with orders not to shoot. Either commit or don't. But the liberals forced a bad compromise on the administration -- that the Marines be used in only a Peace Keeping capacity and avoid all confrontations. We had a military presence, inciting the local anti-American forces, but in a non-military capacity. I wouldn't have sent any arms to Iran. Even if the President didn't exchange the guns for the hostages it gave that appearance, and appearances are always more important than the truth. Ask any journalist. I would have attempted to keep better control over the NSC and CIA, though I doubt any President can be terribly effective at that. Bush will have the best chance at it, since he understands the intelligence community and how it works better than any currently mentioned Presidential hopefuls. Support of the Contras is still a question mark. There is evidence that Nicaragua had started to export problems to El Salvador and Costa Rica. Our allies asked for assistance, and we provided it. If bac'ing the Contras keeps Ortega and his gang busy in their own back yard, then it is a good investment. I still blame the whole affair on Carter. Had he handled the transition of power in Nicaragua the way Reagan has handled it in Haiti and the Philippines we wouldn't need the Contras.

Democrats, who controlled the budget writing House of Representatives all during Reagan's Presidency, are still blaming the administration for the deficit. Make all the cuts the President's budget office asked for since 1981 and there just might have been a balanced budget. We will never know. One thing that is certain: it is the responsibility of Congress to legislate the budget, and the responsibility of the President to execute it. Until Congress accepts that responsibility there will be deficits.

I have heard a lot of Democrate say that the voters were voting mainly for Reagan's personal charisms, and not the Republican agenda. I hope they believe that. Mondale was the one man quaranteed to lose the election? I don't think you can name a Democrat who would have had a chance! Reagan v FDR would have been an interesting race in 1984, and I would have put my money on Reagan. It is probably true that Hart or Glenn may have done better than Mondale did, but they would have lost in a landslide anyway.

As for 1988, I still predict a Republican victory, regardless of who is nominated in either party. The Iran scandal will make it closer than it would have been, but it won't be enough to knock the Republicans out of the White House. Let's say that now the Democrats have a chance where they didn't have one before; let's see what they do with it.>>
