## The problem with Mr. Meese

[[This is an editorial from the Journal on July 29, 1987.]]

The questioning yesterday of Edwin Meese had a weirdly ethereal quality. The American people having decided that Ollie North is innocent of any crime, here were lawyers for the congressional panel in effect asking Mr. Meese why he didn't immediately start reading the Marine his Miranda rights. The real question is, was any of this necessary?

Indeed, it's clear to us that the administration's biggest mistake was the news conference Mr. Meese held on November 25 to break the story of the diversion of Iran arms profits to the Contras, which plunged the executive branch into constitutional purgatory. Recall the chronology: Mr. Meese spent the weekend of November 22-23 investigating what happened to the profits from the arms sales to Iran. On Monday, he told President Reagan about a memo by Lt. Col. North referring to an account for the Contras. By Tuesday morning, Lt. Col. North was fired, John Poindexter was reassigned and the decision was made the Mr. Meese would hold a news conference at noon.

Mr. Meese announced that the diversion was up to \$30 million. The correct figure turned out to be about \$3 million, but this was a comparatively small mistake. The big problem was that in its haste to rush the story out, the White House never thought through its own political, legal and constitutional position. Of course the administration had made mistakes, and now had to get the story out. But it didn't need to roll over. Following the basic line worked out at the White House, Mr. Meese used the news conference to portray Ollie North as Rasputin to a hapless President.

ABC's Sam Donaldson was quick to play ex-officio district attorney. He asked: "Did what Col. North do, is that a crime? Will he be prosecuted?"

"We are presently looking into the legal aspects of it," Mr. Meese replied, "as to whether there's any criminality involved. We're also looking precisely at his involvement and what he did, so that the conclusions as to whether there's any criminal acts involved is still under inquiry by us."

Imagine if instead Mr. Meese had replied in these words, "It is mind boggling to me that Congress has attempted to criminalize policy differences between coequal branches of government and the executive's conduct of foreign affairs. I suggest to you that it is the Congress which must accept the blame in the Nicaraguan freedom fighter matter. Plain and simply, Congress is to blame because of the fickle, vacillating, unpredictable, on-again, off-again policy toward the Nicaraguan democratic resistance -- the Contras."

If these words are familiar, it's because Ollie North spoke them to Congress eight months after the Meese news conference. This is when the tide started to turn against the administration's tormentors. At the first sign of resistance, the congressional balloon popped. If some resistance had started back in November, a great deal of agony and damage would have been averted.

Mr. Meese deserves some sympathy for being gun-shy. He has been investigated for one thing or another just about since he stepped off the plane from California. Accusations of ethics violations

and financial irregularities may or may not come to anything. Though we don't believe it's seemly for the attorney general's financial manager to be chasing hot new stock issues, what is clear is that the liberals have targeted Mr. Meese's scalp because he is a real threat in ending liberal domination of the courts and a symbol of the whole Reagan revolution.

It's not clear, either, that Mr Meese was more than the messenger boy for the decision to defend on the grounds of Presidential ignorance instead of Presidential prerogatives. In watergate, Congress and the press learned the utility of criminal charges such as "obstruction of justice." And Congress has been erecting legalistic restraints on members of the executive with such things as the Boland amendments and ethics in government acts (which do not apply to members of Congress). In this sense, the preoccupation with avoiding the appearance of a "cover-up" was understandable.

Then too, the inclination to avoid a confrontation with Congress fits the administration's whole approach to the Contras. Ideally, the constitutional confrontation should have come over a veto of the Boland restrictions, demanding that Congress either provide effective aid to the Contras or take the responsibility for a communist Nicaragua. Instead, the administration ducked, then ducked again when the crunch came. Ollie North showed that this was not necessary after all.

The lesson of the Iran-contra hearings, it seems to us, is that the next President is going to have to think a lot about his constitutional powers and how best to assert and protect them. He'll need a lawyer, as attorney general or White House counsel, to give the kind of advice Mr. Meese didn't give last November. We wonder if Brendan Sullivan would be interested in the job.

[[I don't think that Washington, Jefferson, or Adams would have put up with in investigatory committee of Congress. Jefferson started the concept of executive privilege by refusing to comply with a court order from the Supreme Court! It is difficult to maintain three EQUAL branches of government. And that doesn't even count balancing the federal interests with those of the individual states.

Now that the hearings are over, I would like to hear what you have to think about the affair. Was a crime committed? If so, by whom? Should President Reagan be impeached if he knew about the diversion of the funds? Should he be impeached for not knowing? Which was the greater wrong, the diversion or dealing arms to terrorists for hostages?

I know what I think, let me know where you stand.]]

Have you heard that scientists are now substituting lawyers for rats in laboratory experiments? They list three advantages:

Over the past two weeks since the legislature finally adjourned (yes, we finally finished, but not without passing the largest state tax increase in history) I have been writing a newsletter to lawyers about the session. We just finished mailing it to the 4,000 attorneys in Travis County, which represents over 1% of the total population.

#### GFL 1987

Well, the draft is done, finally. It was a little tougher than I anticipated, I made more mistakes than I thought I would, and I didn't get the last list until the 16th. By that time I was into my study schedule for finals, so the draft had to wait until August. I hope you haven't been too inconvenienced.

One change we will make for next year's draft is that I will make the deadline later, so that the preseason football books will be out, and I will have a system of penalizing those who get lists in late.

Your team roster shows who you drafted and when (which round and what position in that round). If I made any mistakes that I didn't catch I am sorry, but an apology is all you are going to get. I would conceivably have to change every team roster to repair one mistake.

Overall, I think everyone pretty much got who they wanted. I did close the draft down three rounds early because a majority of you had run out of players on most of your lists (note that Brian Russell has several head coaches -- the only list left with any available "players"). Three players have a 21st round listed so that I could give them a head coach.

An example of why I think that people generally got who they wanted is in the Quarterback draft for Oregon. While completing the 16th round of the draft I found two mistakes in the second round. As I went back through all the lists to make corrections I noticed that Oregon had selected a Running Back in round 3 where he should have been drafting a Quarterback. His correct draft was Schonert QB ATL. I then had to go through all the other rounds that I had completed and take Schonert away from whoever got him. It turned out that Oregon had originally drafted him in round 10! Obviously not many of you thought Schonert was top three round material. I hope you are all happy with what you got, and I encourage you to use trades between now and Labor Day to do any needed fine tuning.

The scoring rule changes will be in effect throughout the preseason and may be be subject to some adjustment prior to the season opener. Please notice that the Punters have been moved to the defensive score and that a fourth goal has been added for all the categories that had three goals before.

Because the draft and rule changes were taking place at the same time, I felt it prudent (most of you who responded mentioned this!) to keep the goals pretty close to what they were when you made up your draft lists. I have been trying to find a way to work in the Special Teams but I can't get the proper goals set and come up with an equitable way to allow owners to draft them. Special Teams seemed to be a popular addition, so help me think of a way to score it and we will add it for next year.

I appreciate all the input that I got, and I tried to formulate a consensus or compromise where possible. Remember that the rules are not written in stone, and we can always go back to last year's system. Check everything over and let me know what you think.
