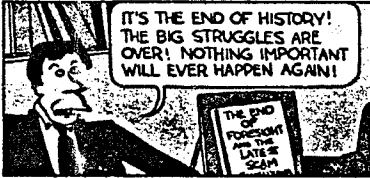

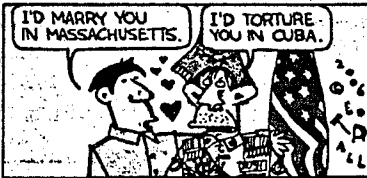
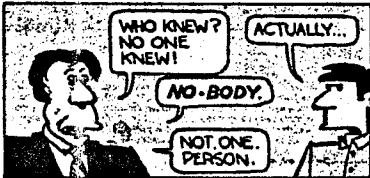

Graustark is the Very First bulletin for the postal play of Diplomacy. It is published every fourth Saturday by John Boardman, 234 East 19th Street, Brooklyn, NY 11226-5302. Diplomacy is a board game of negotiation and conflict for the period of World War I. It was designed by Allan B. Calhamer and is now published by Hasbro. Another new postal Diplomacy game is now being organized in Graustark, at a game fee of \$35. (For Canadian and Mexican addresses the game fee is \$50, and for other foreign addresses it is \$100, or 75 euros in cash.) This game fee includes a subscription to Graustark for as long as the game lasts, whether or not you are eliminated. With your game fee send in a list of the countries you'd like to play, in your order of preference, and I'll try to put you as close to the top of that list as I can. If you do not already have the postal rules for Diplomacy, which were last published in Graustark #749, let me know when you send in your game fee, and I'll send you a copy.

PLEASE STAND BY

Now that I have resumed regular publication of Graustark, I am willing to take over games that have been abandoned by their gamesmasters. So if you are a postal gamesmaster who is no longer able to publish, please get in touch with me and with the Orphan Games Director, Michael Lowrey. (See the Graustark Directory for his address.) If the game is to continue in Graustark, I would need the addresses of all active players, the current position, and a list of who owns which supply centers. If subscription money can be passed along to me, fine. Otherwise I will ask players to join a new game in Graustark, or to subscribe to Graustark if they do not already do so. Players who resign or drop out can be replaced by Graustark stand-by players.

It is best if this is done quickly, should it be necessary. If a game is abandoned for too long, some players may lose interest, and may not continue to play when it resumes under another gamesmaster.

Stand-by players are always needed for postal Diplomacy games in Graustark. If you volunteer as a stand-by, you may be called upon whenever a current player misses a move. If you send in moves for that country for the next turn, and the present player does not, you will take over play of that position. No game fee will be asked, though you should keep your subscription current, or enroll in a new Graustark game. No stand-by will be called upon in a game in which he or she has already played.

DUNGEONS & CHRISTIANS - CXCXV

I have just received the latest issue of the CAR-PGa Newsletter, Vol. 18, #1, published in January 2009 by Paul Cardwell Jr., 1127 Cedar, Bonham, TX 75418. This publication of the Committee for the Advancement of Role-Playing Games carries, among other information, reports on accusations that Dungeons & Dragons (D&D) and other role-playing games (RPGs) are in some way harmful. The most extreme of such reports come from some Christians who actually claim that the demons that sometimes appear to be fought in these games are taken seriously by their designers and players, and that a D&D session is actually a sort of satanic worship service. This is particularly a problem in prisons, whose managements sometimes restrict or forbid the play of RPGs. There also seems to be a belief circulated among police agencies that RPGs are in some unstated way responsible for criminal activity. It will be recalled that the accusation against Michael Crowe and two of his friends, that they killed Michael's sister, were based on the fact that those teen-age boys played RPGs. Eventually, of course, the police interrogations of these boys were thrown out of court, and a drifter was found responsible for the girl's murder.

This issue begins with a report on CAR-PGa's 2008 activities. Apparently the "collapse of the Internet discussion group". CAR-PGa membership is down to 22, although what it lacks in quantity it makes up in quality. Six members have earned doctorates, and three more have gone as far as master's degrees.

Most importantly, "we are still in need of someone with access in the mass media data base, Nexis, for a serendipitous search of major newspapers and news magazines for RPG coverage." Someone with access to Lexis and its references to legal cases would also be welcome. And there ought to be more cooperation between CAR-PGa and the Games Manufacturers Association (GAMA) than currently exists. There are still media reports which blame RPGs for various unwholesome results, and more information is needed about these and about gamers' responses to them. "We still have the same old problem that when a case breaks, the media are quick to blame our games for whatever happened, but as the trial starts, games are left out of the coverage because they rarely come up once perjury may be involved, and once the verdict comes around, it is even more difficult to find out how the accusation was resolved because the case is so old it is rarely front page and therefore is not likely to be indexed (outside Nexis, which we can't get) or picked up by other media."

CAR-PGa Newsletter also includes a list of new publications in the RPG field, and a useful list of upcoming gaming conventions. Subscriptions are \$15 a year for U. S. readers and \$20 a year for others.

Though it does not involve RPGs, there is a discussion of alleged satanic influence in popular culture by Gordon Stein and Marie J. MacNee in their book *Hoaxes!: Dupes, Dodges & Other Dastardly Deceptions* (1995, Visible Ink Press, Detroit). "Some Fundamentalist Christian ministries," they write, "have suggested that Satan prodded rock groups to record satanic messages backwards (backward masking) over the soundtracks of a number of rock albums. The messages could supposedly be heard clearly when the record or tape was played backwards, sending subliminal messages to the brain when played forwards."

The problem with this unlikely accusation is that no such thing actually could happen even if such a message were recorded, as several people cited by the authors have discovered. Besides, how many teen-age rock music enthusiasts are likely to possess equipment that can play records or tapes backwards. Still, "among the groups blacklisted by Fundamentalists are the Beatles, Black Oak Arkansas, Electric Light Orchestra, Queen, Jefferson Starship, Led Zeppelin, Styx, the Eagles, Rolling Stones, Venom, and Mötley Crüe... Many Fundamentalists claim that subliminal messages are present in Christian rock songs as well.... Television evangelist Jimmy Swaggert condemned 'so-called Christian rock' as a 'diabolical force undermining Christianity from within.'"

Two Christian tracts carrying this message are entitled "Communism, Hypnotism, and the Beatles" and "Rhythm, Rock, and Revolution". This, like the accusations against D&D, seem to be the product of the commonly encountered attitude: "If I'm a Christian and I don't like it, it *must* be satanic." An argument allegedly 'proving' this case is then cobbled together.

is also happening), there will shortly be a demand for higher* postal rates. Since U. S. postal rates were increased in May 2007 and May 2008, we may see another increase in May of this year.

There has recently been released a film entitled *Valkyrie*, about the July 1944 attempt by German officers to assassinate Adolf Hitler and negotiate an end to World War II. Tom Cruise, already notorious in Germany for his activities with the nut cult "Scientology", plays Colonel Klaus Count Schenck von Stauffenberg, the leader of the plot. Actually, Stauffenberg and the other officers in the plot were motivated not by opposition to Hitler's plans for Europe and the world, but by the fact that Germany was losing the war.

A number of fortuitous events contributed to the failure of the plot, whose name "Valkyrie" appropriately meant "chooser of the slain" in ancient Norse mythology. Stauffenberg, who had volunteered to take the explosive briefcase into Hitler's

underground bunker in East Prussia, was pressed for time and could not activate the entire bomb. The meeting had been moved from the underground bunker to an above-ground building whose walls could not contain the blast. After Stauffenberg had left the building, another officer was inconvenienced by the location of the briefcase and moved it so that a table leg shielded Hitler from the full force of the blast. And, when Stauffenberg flew back to Berlin after placing the bomb, he was horrified to discover that his fellow conspirators had not seized the propaganda ministry, or shot Goebbels and Himmler, or otherwise done anything to further the plot. These failures doomed the whole plot; Stauffenberg and several hundred others were summarily executed within the next couple of days. By one of those curious coincidences with which history is filled, Stauffenberg was the great-grandson of Count von Gneisenau, one of the leaders of German resistance against Napoleon I.

Most of the German people now regard the anti-Hitler conspirators as martyrs. When I was in Stauffenberg's native town of Bamberg seven years ago, I saw a prominently located memorial to him.
