I assume that you rate all games which Doug says are "regular" and do not rate those he indicates are "irregular". If there are exceptions to that statement, would you send me a list of them and the reason(s) they are exceptions? I'd like this list by Friday, 7 November 1975, if at all possible. At that time also indicate items of business, amendments, possible new members, &c., you wish discussed.
