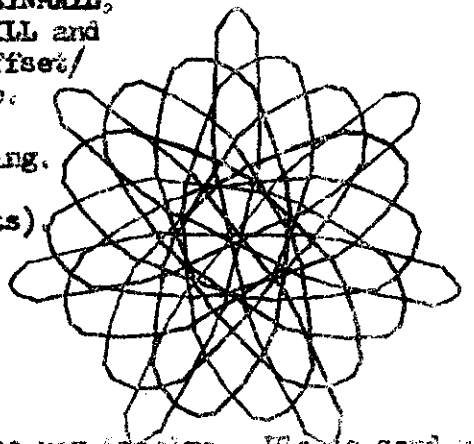

1974 HW analysis

There has not been too much to speak about in the last two game years but the game is beginning to come full circle.

Austria has held on to himself for 5 consecutive seasons. He could contribute to a western overthrow if he began to move. He could and should have blocked tyo. Thus he does not trust his protector Turkey. Will Turkey try to just move around this unhelpful partner in a draw? Would you?

England is trying to peck away at Germany and he honestly expects Germany not to notice. "It's just another supply center Tix, don't worry!" Germany has turned on England/France and may be able to blow the draw--England's win chances are very slim at this point. If England could have kept Germany in line he might have won by stabbing Germany/France. Now that chance is remote. Vagts must decide whether to stick by France or stab him for a piece of the action and then try to get to I borja to prevent the easternpower break out. I would offer Arnold some advice but that would be beyond my rights at this stage.

France is also left with a choice. Does he stick by England or does he stab too? For France to stay alive he has to realize that his life is tied to England. Were he to attack Arnold he would get nothing. France must put up the good fight and hope to get part of a draw. If England stabs him however it becomes a new ball game.

Germany has no good choices. He would like part of a draw but he can't trust England to give it to him. England has been eating away at him and he has little choice but to make himself as much of a thorn in England's side as possible. Be sure to watch F Ber--Arnold is!

Italy has had little to do. Now that the pressure is coming off of him he might be able to become offensive--or mount an offensive. Turkey is in place to offer support to Ven so that Ion, Ron and Nap can begin to apply pressure on Tyrr.

Turkey has the degrees of freedom now. He has an ally in Germany, Italy is his friend and Austria has at least been quiet. Turkey can try to stab Austria or Italy but then he must be careful that their death throws do not give him the same problems England is now struggling with! Tactically Turkey's last move was brazen but it worked. France has not been innovative in the past and Don took the chance that he would not become so this season--BRAVO!

France will have trouble finding a good removal. If F Wes goes so does the Tyrr and probably Tun by 1908. If he removes a Pied or Tyo his attack power is gone. If he removes Gas his defense against Germany (England) is gone. What would you remove--it is a difficult decision. I would remove....but that would be telling!

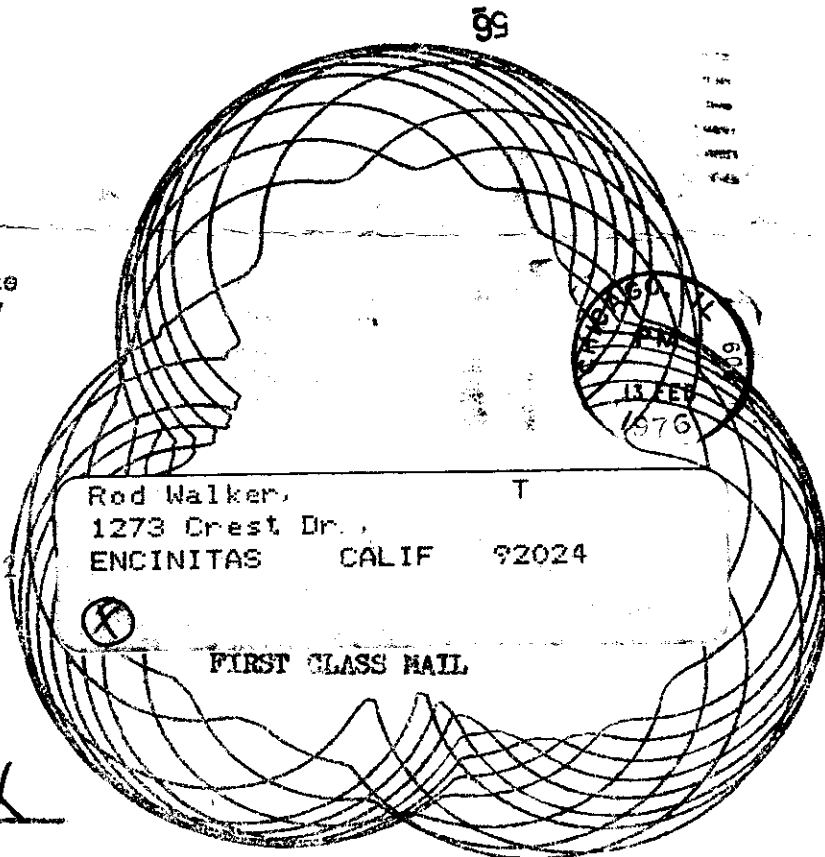
