## STUFF

MURD'RING MINISTERS is a gamezine dedicated to the play of Postal DIPLOMACY and other postal multi-player wargames. The cost of a 12 issue subscription is \$5.50. Gamefees vary so check out the GAME OPENINGS section if you are interested in joining a new game. MM is normally published once a month (approx.) utilizing three week deadlines for games. Sometimes, however, mid-month editions (such as this one) will supplement those going out monthly. Just last month in Issue #26, I mentioned that there might well be an occasional mid-month edition of MM on an experimental basis. Well here is the first one. 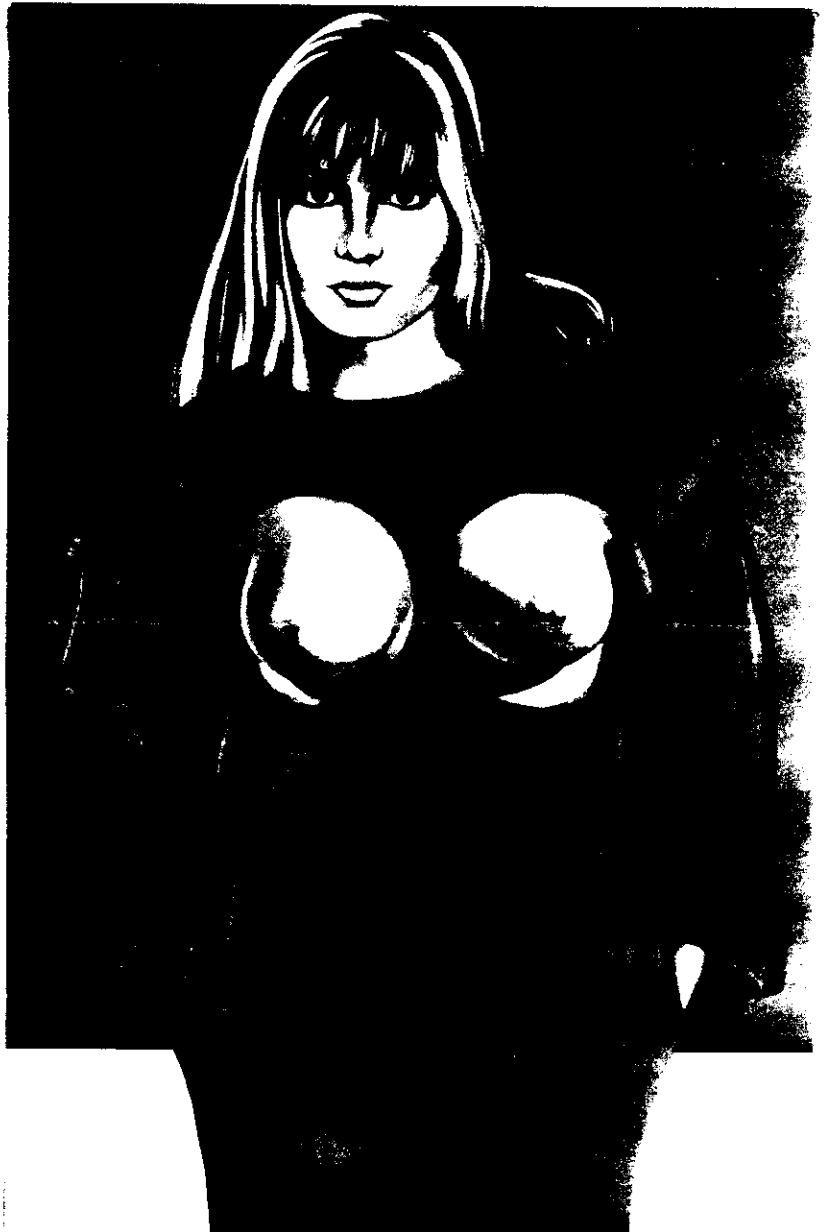
This is the outfit that I will be wearing at Dave Grabar's Grabar-Con later this month. I hope to prove its effectiveness by winning every game I get into at Dave's.

Giving up one home center in 1901 with only a fifty-fifty chance of gaining two neutrals is not an especially viable option and this is primarily why Nicky Palmer redubbed the thing "Gascony's Suicide" in 1978.
