Remember last year's fake *Chocolate Factory* that reported (incorrectly) that Bruce Linsey was running the DIPCON tournament in San Antonio? Well, any 'zine that lists me as the Tournament Director for this year's DIPCON in San Diego is...not a fake.

That's right, folks - Larry Peery has named me as the Tournament Director for the regular Diplomacy section of this year's DIPCON. **More news from AREA:** I asked the AREA technician what happens in case of a draw in a multi-player game. The reply: "treat each person in a draw as a winner against the losers". This makes no sense: suppose all seven players have the same rating and there is no halving of points. A sole winner receives 10 points (70 divided by 7 players) from each loser (total 60); each person in a 2-way draw receives 10 points from each loser (total 50 each - but the losers lose 20 each instead of 10). In a six-way draw, the loser loses 60 points! NOTE that a draw including ALL players is considered NOT TO HAVE BEEN PLAYED!

# MEETING OF MINDS #27

This is *Meeting of Minds #27*, the subzine of International Diplomacy Tournament Ratings (IDTR), published by the IDTR Chairman, Don Del Grande, 142 Eliseo Drive, Greenbrae, CA 94904-1339, USA. If you didn't see the 1988 final standings on the front cover of this issue, ask someone on the MIDCON committee for the details.

Anyway, with DIXIECON taking place while this is being mailed, it's time for a quick look at some of the upcoming tournaments:

**NEW SOUTH WALES CHAMPIONSHIP** is next on the schedule, so if anybody is planning to be in Sydney in mid-June (maybe you can take in a Swans match or watch the Aussie cricketers in England on TV somewhere), contact Luke Clutterbuck, 16/353A Old South Head Road, Bondi Beach, NSW 2026, AUSTRALIA for details.

Back to America for **ORIGINS** in Los Angeles, June 29 - July 2. The Diplomacy tournament is scheduled to begin at 9 AM on June 29. Registration forms are available in major wargaming magazines; you can also register at the site (beginning June 28), which is the Los Angeles Airport Hilton. At-the-site registration is \$30 and includes all game fees.

The largest tournament of the year is likely to be **MANORCON** in Birmingham, England, July 7-10. This is a two-round event featuring the British "Team and Individual Championships". Contact Richard Walkerdine, 13 Offley Road, Hitchin, Herts, SG5 2AZ, U.K.

Robert Sacks is scheduled to be running the **ATLANTICON** Diplomacy Tournament in Baltimore at the Convention Center and Sheraton. For registration, write to ATLANTICON, 37 Woods End Road, Middletown, NJ, 07748.

**DIPCON** will be held at - well, either Larry Peery's residence or the Town and Country Hotel in San Diego, depending on whether there are less than, or at least, 50 persons attending. Send your \$22 registration to Box 8416, San Diego, CA 92102.

DIPCON XXII is being run slightly differently from the first 21 in that the "overall tournament results" will be based on performance in not only regular Dip but variants (including Gunboat) and even computer Dip. However, only the regular Dip sections will be considered for determining the results as far as IDTR points are concerned.

The game notwithstanding, the big talk so far seems to be centered on the **WORLD DIP CON 90** site selection meeting to be

held sometime during the tournament. There are two favorites: DLXIBCON and a still-being-worked-out site organized by Robert Sacks. Meanwhile, the mystery of the "WORLD DIP CON" logo on the DIPCON registration form has been solved - it was a mistake on Larry's part.

Waddington-Sanders, who produce Canadian versions of Diplomacy, are part sponsors of CAN-CON, being held August 4-6 in Toronto. Unfortunately, I received the flyer just after the last publishing date, and the June 1 "cheap housing" deadline has passed, but there's still time to register for the tournament. (There should be a form enclosed; note the fee is C\$20, which is less than US\$20 until you include the fees for converting the money.)



**AREA-RATED DIPLOMACY** - Martin signed up. Need six more. No NMR deposit needed, but those who drop out will be reported to AREA and are subject to whatever they decide.

**STANDBYS** needed for Diplomacy and Kingmaker - there's sub credit for those who are called; 50 cents for your first set of orders, 50 cents for your second, and one dollar for finishing the position.

## SPECIAL NOTE FOR TALISMAN PLAYERS

Rich Hanson has expressed interest for both himself and his son to play Talisman. Normally, two members of the same family would not be allowed to play in the same game, but (a) Talisman is not at a level that's as "serious" as, say, Diplomacy (nor is there as much dependency upon other players), and (b) this is more of an experimental game, anyway - the PBM rules haven't been tested under actual gaming circumstances. If the two other players (Stephen Dorneman and Rick Pierce) don't object to the two Hansons playing in the same game, and if I can write up the PBM rules, the game will begin in the next issue.

# DIP WARZ ELECTION SPECIAL

And as the polls are beginning to close throughout the eight corners of curved space, it's time to discuss how things actually work - probably the one time this actually happens. Anyway, each planet receives a population

value - from 1/2 for those postage-stamp-size planets, at least those that haven't been used to send intergalactic mail, to a whopping 3 points for those big ones that always happen to eclipse your favorite sun just as it's about to set over that particular spot in the ocean where the colors are just the right shade of pink. As to how each election happens - well, that's left up to the planet in question, which only goes to show how many different ways you can come up with a predetermined result.

This time around, there are three parties actively contesting THE EMPERORSHIP - the recently deposed EMPEROR, Rod Seaparter; his predecessor, Lord Sacks Fifthavenue; and a mysterious Diplomatic Bad Boys candidate to be named later. Excuse me, but the first results are coming in - take it away. Obladee planet in the (I can't believe I'm saying this) Ringo star system...

"Well, the voting has been fast, furious, and, unofficially, early and often. The election officer-in-command is posting the final results, and Seaparter appears to have nosed out the DBB by about 26,000 votes, or about 0.1 percent here. One point for - just a moment; the INQUIRY sign is lit. The election council has demanded a recount. More on this later."

We'll be waiting for word from Obladee as it develops. Now onto the People's Republic of Berkeley Exiles planet in the Eastbay system, where things have been exciting to say the least:

"There's been an exceptionally heavy turnout here this time; over a dozen people actually bothered to go to the polls. Yes, 15 ballots have been cast, and the majority have decided that rent control will be strengthened so that no landlord can increase by more than 100 percent per year, although in Earth terms that's only 67 days. Meanwhile, in the EMPEROR election, the pro-Seaparter student faction clashed with the pro-Lord Sacks student segment, resulting in a large number of pro-Lord Sacks casualties as they were outnumbered 40-1 despite being the largest registered organization



there was one person who had been waiting outside of his polling place for four hours reading a pamphlet entitled 'How to Survive an Upcoming Asteroid Impact'. This resulted in Lord Sacks Fifthavenue receiving a 100 percent vote here, and he picks up the three points. And what a coincidence: one of his Asteroid-Orbit-Shifting ships has landed and picked up the voter."

We've just received word that the voting on the Middle of Nowhere planet has been cancelled due to its being used as postage on sending the Darkside Dare planet to the other side of the galaxy. Meanwhile, back on Obladee, a mysteriously-appearing ballot box has been found and the DBB have won by 2 votes. The Election Council have upheld this result. Tough luck for the Diplomatic Rebels here. Maybe they'll do better on the EGGhead planet in the TSaR system:

"There's a lot of commotion here because of the recent release of the second edition of the Election Code. Despite secret underground meetings of the Imperial Election Council, occasional glimpses by the general public, and rigorous computer testing, it is the consensus of the voters that the second edition of the Election Code is every bit as confusing and ambiguous as the first, so they'll do what they did last time - swords UP and (CLANK CRASH STAB SPURT THUD BASH CLANG CRASH CHOP THUD BOUNCE) the Diplomatic Rebels representative takes it - three points for Seaparter from here."

It seems as if Seaparter, Lord Sacks, and the DBB are splitting the votes. As this is an unprecedented situation, we'll ask the Keeper of the Imperial Diplomatic Archives on the Oily Linseed planet what the Official Election Rules say. We'll let you know when he finds - we've just been informed that he's found the master index and is searching for the location of the index entry. It seems that the index containing the location of the appropriate law is itself some 200 km from the master index. My mistake - the computer is 200 km away. (Mere seconds later....) The laws in question have been researched and are being made public right here: apparently, back in the days predating even EMPERORS Conrad von Mefirst and Yawn Boring, a similar situation existed. In this case, the three competitors got together and decided things in the true Diploamtic Empire way - plenty of talk, plenty of blood, and no prisoners taken.

Unfortunately, it's time for the Match of the Week, and our contracts with the sports leagues give them broadcast priority, so that's all for now. (Did you know that NBC once stopped showing "The Skins Game" at the 18th Hole - for \$180,000 - because it was time for football?)

## **1830 "STARLIGHT EXPRESS" - TURN 1**

Well, Scott Nixon is out, so there are five players in the game; each of you begins with \$480. Meanwhile, Conrad von Metzke can't get his hands on a copy of the game at the moment...

**DICK MARTIN bids on C&A (max bid 225)**

**JIM GOODE bids on B&O (240)**

**RICH HANSON bids on D&H (95)**

**RICK PIERCE also bids on C&A (170)**

**CONRAD von METZKE passes**

**DM bids on C&SL (50)**

**JG bids on D&H (80)**

**RH passes**

**RP buys Schuylkill Valley for \$20**

**DM buys C&SL for \$45**

**RH buys D&H for \$85**

**RP buys M&H for \$110**

**DM buys C&A for \$175**

**JG buys B&O for \$225**

Note that in those cases where only one person bid on a company while another company was "currently being offered", the selling price is \$5 more than the original price (as a bid must be more than the face value - rule 7.2). Schuylkill Valley and M&H were sold at face value because nobody bid on them prior to their becoming "currently offered".

**DM receives a 10% share of PRR; RP receives the 20% President's share of B&O. (RP can also exchange the M&H for a 10% share of NYC.)**

There is no revenue collection yet; Corporations may now have their stock bought and sold. Since Jim Goode made the last transaction, the order of play as of this moment is Hanson, Pierce, von Metzke, Martin, and Goode. (In effect, Hanson receives the "Priority Deal" card.)

**The next turn consists of a Stock Round and an Operations Round. Remember to write orders for Corporations which you may own at the beginning of the Operations Round - include a Par Value for any Corporation of which you could be President. (Rick Pierce should state a Par Price for B&O, as he is already President.)**

## **RAILWAY RIVALS "STOP THE WORLD, I WANT TO GET OFF" - TURN 9**

**LONDON-PRESTON (61-31):** GOERS first, GRCO/ECU joint run second. GOERS pays 1 to ECU and 4 to GRCO.

**LEICESTER-NORTH (44-S4):** NUT first, GRCO second, COSALT third. GRCO pays 7 to COSALT; NUT pays 3 to SEX.

**MANCHESTER-NORTH (26-S3):** GRCO first, SEX second, GOERS and COSALT also ran. GRCO pays 3 to GOERS; GOERS pays 4 to GRCO.

**PETERBOROUGH-BRISTOL (46-55):** GOERS first, NUT second, ECU first. GOERS pays 1 to SEX and 8 to NUT; NUT pays 1 to SEX and 3 to GOERS.

**GRIMSBY-LONDON (11-63):** COSALT was the only runner. COSALT pays 1 to ECU.

**DONCASTER-HUDDERSFIELD (15-21):** GRCO first, NUT second, SEX third. GRCO pays 1 to SEX and 3 to NUT; NUT pays 1 to SEX and 2 to GRCO.

**GLOUCESTER-SHREWSBURY (56-33):** NUT first, ECU second. ECU pays 4 to NUT.

### **TURN 9 BUILDS**

**GRCO:** no builds

**GOERS:** C 11 - B 11 - A 12; Wolverhampton - F 17 (pay 1 to NUT for F 17); K 61 - N 62 (pay 1 to ECU for N 62). *Note that GOERS built one too many in turn 8, so C 11 - B 11 had to be rebuilt. There is no payment to COSALT for Wolverhampton - F 17 as both built this route in this turn.*

**NUT:** Leicester - N 17 (pay 1 to GRCO for N 17); I 16 - H 15 - H 14 (pay 1 to COSALT for H 14); F 13 - G 14 (pay 1 to COSALT for G 14).

**ECU:** H 58 - H 57 - I 57 - I 52 - G 53 (pay 1 to SEX for I 55 and 1 to COSALT for I 52); E 31 - E 32.

**SEX:** E 58 - E 59 - Leicester (pay 7 to GRCO for the entire route); M 64 - M 65. *The remainder of Melinda's builds were discarded as she has reached the limit of 10 points.*

**COSALT:** Wolverhampton - F 17 (pay 1 to NUT for F 17); M 7 - Huddersfield.

Current standings and Turn 10 runs are on the next page - meanwhile, David Watts noted that each pair of numbers didn't appear as the first numbers in a run during turns 7-9; for example, there was no run between sectors 1 and 3. See the next page for the reason . . .
