HOW TO BE ORGANIZED

((Ed. Note: Those who know Matt personally know of the amazing degree to which he is organized. His filing systems are the envy of every archivist from here to Indiana. I asked him to reveal the secrets of his organizational skills, and at first he was very reticent, complaining that I would "blow his cover" and "how can I tell all those people out there what I really do?" However, with appropriate threats I was able to convince him that it was in his own interests to write the following article.))

If you want to play in 25 games, receive 20 'zines and do other hobby chores all at the same time, one skill is a must -- organization. A poorly organized Big Name Fan does not remain one for long; he is soon forced either to contract his activities to suit his organizational capacities, or to get organized.

One system of organization which works very well is the "put it up on the wall" method. This involves taping all addresses, deadlines, orders, appointments, etc. to the wall. It is hard to forget a deadline when it is staring you in the face every time you sit down at your desk. In order to make moves all you are required to do is look up at the map. This system works rather well, but after a few months the tape tends to yellow and sheets fall:

Another system is the mailbox-to-garbage-can system. All this entails is opening the mail, skimming it and throwing it away. Then all you have to do to find something out is telephone someone who uses another system. Unfortunately, most Diplomacy players are avid collectors and can't bear to part with anything, particularly mail, which they build their livelihoods around.

The system I have found most convenient is a sort of modified filing system. All of my Diplomacy paraphernalia is divided into three files: the floor file, the desk file, and the draw file. The draw file is a very neat organized collection of old 'zines dating from about 1973-4. These arm vestiges of the neat days when I felt something had to look nice to be organized.

I now know better. I have not contributed to this file in two years. Next comes the desk file: I place all of my mail on my desk where it remains for about two or three weeks; after that, I shove it all (usually a good arm load) onto the floor where it remains permanently -- thus creating the floor file. I recommended that those gamemasters who wish to adopt this system do not inform your players that you are doing so. Several players have raised their voices at me when they found out where I was keeping their precious moves.

Therefore I recommend gamemasters use the Gil Neiger system of filing moves. Whenever you receive a set of orders, put them in your pocket, transfer them from pocket to pocket as you change your pants, then on deadline day they are all in the same place. Gil used to forget to transfer them and as a result ended up making many long distance phone calls; so be sure you do transfer them.

I should also point out that no matter what system you decide on it is useful to have the phone number of someone who hasn't read this article. In New York the best people to call for information on deadlines, articles, etc. have always benn Ray Heuer (212-441-7757) and Edi Birsan (212-476-0984).

Other good systems which are self-explanatory are the fireplace system, the under-thebed system, the paper-shredder system, the "but I never got my issue!" system and the return-to-sender system.

Robert Sacks, Bureaucrat

OR, WHY DO YOU THINK THEY 'RE CALLED "ROBERT'S RULES OF ORDER"? My first impression of Robert Sacks was a good one. He came to my notice when he wrote a letter to the (then) infant CARN DUM and complained about something Evan Jones had said in his Origins column. Well, what could be wrong with anyone who disagrees with Evan.?

Unfortunately, people who have followed Sacks' exploits for -- I think -- almost two years now have seen that there can indeed be something wrong.

Before I elaborate, let me assure you that this is an article to highlight some of Sacks' problems with things. There are obviously many things right about him -- to wit, he is a hard worker, he certainly does care about variants, and he usually has good ideas to contribute.

But Robert's good points are too often beclouded by his faults, chief among which is an amazing willingness and capacity to emit reams of material -- an attribute that astute observers will immediately recognize also belongs to Lew Pulsipher. But where Pulsipher's stuff is readable -- though usually very dull -- Sacks' is eminently unreadable. Aside from his use of half-page paragraphs and twenty-line sentences full of titles, acronyms, and useless accoutrements, Sacks seems to have an incredible tendency to shy away from discussing issues and ideas and instead discuss paper institutions, political fictions, and protocol and procedure.

Some of this stems from Sacks' admitted infatuation with "imperial" protocol. "The Imperial Diplomacy Association" was the culmination of this trait, an amazingly pointless group so weighted down with procedure and title that whatever functional apparatus it contained were rendered useless. It wasn't even funny.

But we should look further. You may remember that Sacks complained, during the IDA'DVC transitionary period, that he had tried to run IDAVC as an IDA committee but that the rules just didn't work. Sacks is the only committee chairman ever to complain about such a thing. He is also one of the first to chime in that some particular detail of IDA Council procedure was not according to Robert's Rules, or whatever.

Robert doesn't understand that an organization has to have a proper mix of institutions and rules, and people. While others have gone in the opposite direction, building an organization too much around people, or one person, Sacsk goes the other way -- so fouling his group's human elements that, usually, little gets done. No small organization composed of 150-200 people, with an executive group of 13, can operate under a strict, unbendable set of rules. Even the U.S. Constitution, which governs 230 million people, and has executive groups of 100 and 450, has been subject to very wide interpretation. Unprecedented situations come up, and people, not rules and institutions, must, and only they can, properly react to them.

I realize I've become slightly enmeshed in political philosophy here. My main intent is to persuade Robert Sacks to alter his political methodology somewhat to make room for people. I don't intend this as any sort of "attack" and people who call this "feuding are obviously just looking for ammunition. I think Robert Sacks' integrity and honesty are among the most impeccable in the hobby.

The postal rates have risen, but our rates won't -- not for a while yet, at any rate. We're saving a little money on the shorter issues.

SUMMON AID: Allows Klansman to summon National Guardsmen to enforce segregation or assist in dispersing high-level protestors.

MACE: Throws clouds of mace at picketers which causes temporary blindness, coughing, and regurgitating for up to three turns.

TEARGAS: Same as Mace, but lasts until dispelled.

MAGICAL BARRIER: When cast, this spell causes the Klansman to be surrounded immediately by a wall of swinging ax handles, doing 4 to 10 hits of damage to anyone attempting to penetrate it.

HIGH PRESSURE WATER HOSE: Causes a stream of high pressure water to pummel protestors, minority group members, or others of the Klansman's choosing.

RESTRICT FORTAL: When cast upon a doorway, this spell renders said door impassable to members of a specified minority group.

NOTE: For Ant-Klansmen (or "Bleeding Hearts") these spells are reversed; i.e., SUMMON AID becomes FEDERALIZE GUARD and the soldiers thus conjured will then assist in protecting marchers or de-segregating. SEGREGATE becomes INTEGRATE, and so forth. Also, OBTAIN SUPREME COURT RULING, a spell which allows the Anti-Klansman to commune with a higher authority and call for a decision. If the court is reaches a decision against a given Klan measure, that Klan spell is immediately STRUCK DOWN and its effects are retroactively neutralized.

Note, however, that there is a ten-percent chance that the court will refuse to hear the case, and a thirty percent chance that the court will waffle, and render a useless decision. The court may be contacted only once per day if a decision (waffling or not) is reached, but if the court refuses to review the case in question it may be petitioned repeatedly until some action is taken.

Note also the Klansmen are extremely resistant to black magic. They will not tolerate elves, dwarves, ents, hobbits, or any other "funny-looking" entities in their parties. They are white, with elongated heads tapering to a point at the top. They are known for their meetings at which fire and tar are used extensively. Recently, the most organized tribe has hired a Madison Avenue ad agency to improve their image.

The IDA Judiciary Committee is investigating the default on Dipcon prize fees. It seems Gordon Anderson has not paid the 1974 Dipcon prize maney to Mike Rocamora, nor has he paid the 1975 prizes to Wartenubrg and Blank. Let's hope for some action on this -- soon.

This is the second in a series of responses (and denials) to Lewis Pulsipher's Verhandeln; both are submitted to IMPASSABLE, PAROXYSM, SPECULUM, and THE POCKET ARMENIAN. It is unfortunate that after his noble attempt to propose something constructive in his first article, rather than propose something constructive for variants (advocacy of any one of Variant Handbook, Catalog, Bibliography, Ratings, Orphan Rescue Service, Certification and Insurance, Playtesting Service, Combined GameeOpenings Lists, Almagamation ((sic)) into Regional Zines a la PAROXYSM, MN Recategorization, or: Awards) he chose to attack an official public notification of by the Miller Number Custodian that, in sum, IDA has embarked on a policy not well intentioned towards variants.

First, for those of you who are unfamiliar, I am obligated to present my credentials --I am the Miller Number Custodian and the Secretary to the Diplomacy Variant Commission, and before the IDA orphaned DVC it was the IDA Variant Committee and I was its chairman. The IDA Variant Committee was supposed to advise IDA on variants -- to be best able to do this the Committee decided on certain developments: the inclusion of all principal variant officers by right; the assumption of responsibility for projects developed in committee; and the adoption of rules of procedure which allowed simple majority decisions (rather than absolute majority decisions as required by IDA). Throughout this development the option was deliberately left open for IDA involvement, because a principal consideration was the provision of the best possible advice to IDA, and I requested a poll OF the IDA Council on their attitudes and participation by IDA -- however IDA declined even to recognize DVC, setting up instead a new variant committee (which as yet has done nothing) as an advisory rump ((sic--it is not a rump group; if anything, DVC is)) without right to expand or act, clearly a rival since DVC had already begun to provide advice to IDA, and has been doing so since then, even though IDA has declined consideration ((untrue)). Since Pulsipher disputes this last point, I will now list all the topics I can remember (in variant affairs) that the Council has ignored: my requested poll of the Coumcil on DVC structure, my request for IDA to recognize DVC as successor to IDAVC (defeated) ((WHAT A FARCE: How could it have been ignored if it was defeated???)); DVC advice for the institution of an elected IDA Variants Secretary ((This is now under consideration by the IDAVC)), DVC advice for a policy to make capital grants to begin WVB branches in each continent as the hobby spreads ((so is this)), ((This sentence, paragraph, and article to be continued next issue).


