

The next issue will contain statements on why the editors are now firmly committed to the proposition that Richard Nixon should be impeached and removed from office. However with events moving as quickly as they are now, we wish to make the following statement with this issue.

You may or may not feel that Richard Nixon should be removed from office. You may or may not feel that Richard Nixon should be impeached and tried. We urgently feel that this is clear: Richard Nixon's presidency has been the most currupt in the history of this nation. He has committed many impeachable offences. Previous to today it has been well argued that impeachment would create far more problems than Richard Nixon's trial would solve. This is now totally nulified as an acceptable argument. The President has openly flouted the authority of the Constitution and his oath of office. Since the Civil War our Republic has not been so threatened. With the events of this weekend he must be brought to trial and held responsible via the process of impeachment. Until he is removed we are each responsible for the violation of our principles. We are not worthy of our heritage if we do not respond now to our duty to do all in our power to uphold our national rights, heritage, and responsibilities.

We do not say this lightly or rashly. We have given this a great deal of thought and it is a source of great sorrow. There is now no turning back.

If you do nothing else, write your Congressman. From personal experience we can guarantee you that your personal letter or telegram will have great impact. Members of the House pay great attention to each and every letter and telegram. Do not write your Senators, they do not have a say on impeachment, and they must be impartial jurors in the event of impeachment. Write your Representative at: The House of Representatives, Washington, D.C. Also, write the chairman of the House Judiciary Committee, to which bills of impeachment must go. He is Congressman Peter Rodino (D = N.J.)

For \$2.00 you can send a telegram of 100 words to any Congressman. Call Western Union at 800-325-5500, 800-627-2211, or 800-257-2211. Tell them you want to send a "mailgram." Or send a "Public Crimion Mossago" of fifteen words for \$1.00. Do it as seen as possible. It is very important. This is your responsibility as one who benefits from the proper functioning of our Republic. Congress is being fleeded with messages, we make the difference. The Judiciary Committee is one of the more liberal committees of Congress.
