Certain Observations on the Perambulating GM Role and Seitenstetten Rules

Away back in Ss 3, Conrad posed several potential problems on page two. To the best of my knowledge nothing has been done to confirm our handling of these issues. Primarily they deal with missed moves, tardy publication and situations where a scheduled publisher can't (or doesn't) make it. His final paragraph appears to have been accepted in that whenever a non-publishing player misses a turn, the standbys will be asked to submit orders for the next season (he would be replaced if the standby orders had to be utilized the following season). But you can't do this with the GM.

It seems to me that there is a relationship between delinquent publishing and mispublishing as brought to our attention by John. Delinquent publishing can lead to situations where the game is seriously disturbed unless some "judge" has access to the moves. Agreed that we are a reliable lot, but I cite the difficulty I've encountered in getting 1972BD going, and that came from one of the most reliable publishers extant.

On page four, Conrad suggested players take action to make it easier for a GM not to open moves prematurely. The enclosed envelope appeared most reasonable to me. After all players do write one another in this game (don't they?), and how is the GM to tell if an unmarked envelope contains "national" communication to be read immediately, or GM material that should not be prematurely read? It was quite interesting for me to note an unusual corelation between the care players exercized in sending these moves to me and the vote on issue two. The players who clearly marked what they didn't want opened seem to be the same ones who want to see the game to be conducted on a basis that would tend to minimize question or doubt.

Others seem to prefer the honor system. Could this be an experiment?
